FRUIT GROWERS UNION.

That there is profit as well as strength in union has been clearly proven by many fruit growers of Oregon during the past season. In the work of handling the fruit the various unions of this state have proved a success and have enabled the fruit raisers to realize a better price than they would have realized by handling their crop themselves.

The growing of fruit did not really become a profitable, settled industry in Calitornia until the fruitmen united their interests and formed unions through which to market their crops. The fruit industry of Oregon will not be reliable and profitable until the growers are able to handle their own crops and this can only be done through unions. The glutting of markets and breaking of prices can only be stopped by the growers working together and having reliable agents in all the markets and thus keep themselves posted as to where and when to ship.

The matter of freight alone is of sufficient importance to make the maintaining of growers that can load a car of one variety of fruit at a time, and if compelled to ship in small quantities the freight charges absorb all the profits. A union that is fully established and is handling fruit by the car load can secure far better rates than any small shipper.

If the fruit growers of Clackamas county are to compete successfully in the markets of this place. of the country they will have to organize and be able to handle their crop as a unit. In shipping as individuals, as is now done, it is impossible for them to maintain them-


