**MAKES A FULL CONFESSION.**  
**Lloyd Montgomery Kills His Father and Mother at Brownsville.**

On Tuesday of last week, one of the most fiendish murders that ever darkened the history of Oregon, was committed. Lloyd Montgomery shot and killed his father and mother and a neighbor, Daniel McKercher, near Brownsville, Linn county. Young Montgomery is certainly a brute and monstrosity of the Durrant stripe, and it is unsafe to allow him to exist. Last Sunday Montgomery was prevailed upon by Sheriff McFerron at Albany, to make a partial confession. All day last Monday the prisoner appeared to be in a distressed state of mind, and in the evening an Albany Herald representative obtained a complete confession from him, which is substantially as follows, told between fits of weeping in answer to questionings:

"Oh, if I only had it to do over again; I don't know what made me do it."  
"McKercher asked father how he was fixed for money, that he would like to get a few dollars father owed him. They were talking about that, and were speaking in a friendly manner. McKercher asked for a drink of water and I got it for him."  
"We were quarreling, father and I. Father commenced going after me for going away from home and neglecting work. He had always abused me. McKercher sided in with father while we were quarreling. Father asked me where I had been. I told him I had been hunting. Then he slapped me in the face and told me to go and cut some wood. This made me so angry I did not know what I was doing. I went into the house and got father's rifle. It was in the bedroom. I came out and stood in the kitchen door. Father and McKercher were still standing by the fence talking and mother was standing near by in the yard."  
"I was so excited that I don't know just how they were standing. I shot father first. Then mother and McKercher started to run toward the house. I shot at McKercher and missed him the first time. I jumped out of the doorway where I was standing and ran around the house toward the front porch. McKercher was just going through the door. I was still standing on the ground when I shot him. He fell near the door inside the house and I stepped upon the porch. Mother was running from me through the house."  
"Here he broke down and sobbed: 'I don't know what made me do it. I just got to shooting and kept on until I shot them all. I had no idea of killing them until I got so mad and then I didn't know what I was doing until it was all over.'"  
"No; I don't know that I placed the gun on McKercher's body for the purpose of directing suspicion to him. I don't know why I did that. I just laid the gun down and ran. My first thought was to get away. I ran out in the field for a short, but saw the children nearby coming home from school and came back with them. It was father's rifle I used the same one I had taken hunting. It was a Winchester. I shot five times."  
"I had worked hard all my life, and my father always treated me mean and abused me."  
"The prisoner said he had a violent temper and was easily angered, and added: "When my father slapped me it made me so angry I did not know what I was doing."  
"The prisoner said he was 18 years old in August last. His miserable confession, told in a halting, distressed manner, with frequent outbursts of weeping, could not but excite pity, yet this is overshadowed by the enormity of the crime committed by the young monster in shooting his father and McKercher without warning, and then shooting his mother twice as she was fleeing from him and begging for her life, with no other apparent motive than that inspired by his ungovernable temper and furious anger aroused in the quarrel with his father over a trivial matter."

Report of school District No. 10, for the month ending November 15, A. B. Hibbard, teacher: Average number pupils present, 132½; average number pupils absent, 14½. Pupils are counted absent only for the days lost after being enrolled for the month.  
Fifteen visitors registered during the month; average time of visit, one hour forty minutes.
