Appeals His Case.

The documents and a transcript of judgment from Justice Schubel's court, in the case of State vs. A. W. Hertzka, were filed with the clerk of the circuit court Friday on an appeal entered by the defendant's attorney, J. R. Stoddard, of Portland.

Defendant has filed the following brief:

"Whereas, the defendant in the above entitled action has appealed to the circuit court of the State of Oregon for the County of Clackamas, from judgment of conviction rendered in the above entitled action in the above-named court on the 23d day of February, 1900, adjudging said defendant guilty of practicing medicine without a license, and that he pay a fine of \$100, and in default of payment of said fine, to be confined in the jail of this county not to exceed 50 days."

"Now therefore, in consideration of the premises, and of such appeal, we, the undersigned, A. W. Hertzka and I. G. Davidson and J. W. Going, of Multnomah County, State of Oregon, do hereby jointly and severally undertake and promise on the part of the appellant will pay all costs and disbursements which may be awarded against him on appeal."

Seba Norton Is Dead.

With regret we chronicle the death of Seba Norton, of New Era, who died of pneumonia at his residence Sunday morning at 9 o'clock. Mr. Norton was 60 years of age, and leaves two daughters and a son. His funeral was held from his residence at 10 o'clock yesterday morning, and was largely attended. The services were conducted by the Masons, he being a prominent member of that order.

Last Resting Place.

The funeral of John Shadie took place Saturday afternoon and was a very imposing affair. The services were held at the Presbyterian church, Rev. A. J. Montgomery, officiating. The funeral train consisted of a large number of friends, the G. A. R. corps and members of the Woodmen of the World.

Mr. Shadie was a native of Pennsylvania, spending a number of years in Kansas, from which state he moved to Oregon in 1889. He was 54 years of age, and leaves a wife and two children, Katherine and Silas. He was a member of Moose Post G. A. R. and also of the Woodmen of the World in which lodge he carried an insurance of \$1,000.

After a lingering illness of six years, Mrs. Charity Offield died at her home in Russellville, March 2, 1900. She was an early pioneer of this state, crossing the plains from Missouri in 1859. The deceased was 81 years of age, raised a family of ten children, eight of whom are still living, and was a member of the Methodist church. Pleaser Passed Away.

Major J. S. Rinneborn, of Rainier, Oregon, died at the home of his niece, Mrs. O. E. A. Freytag, at Gladstone, last Sunday evening. The cause of his death was heart failure. The deceased was born in Pennsylvania 86 years ago, and crossed the plains with an ox team in 1843, coming to Oregon. He was a Cayuse Indian war veteran, and was once stationed at Vancouver. The services at the grave were conducted under the auspices of Multnomah Lodge No. 1, A. F. & A. M.
