An ordinance authorizing the issnance of bonds for the purpose of refunding out-standing bonds heretofore issued by Oregon

Oregon City does ordain as follows: Sec. I. Whereas, by an act of the Legis-Intive Assembly of the State of Oregon. approved February 25th, 1896, Oregon City ue bonds to the amount of fifty thousand dollars. Bec. II. And, Whereas, in order to pro-

ride for the payment of certain bonds of Oregon City heretofore issued to the smount of thirty thousand dollars and due May 1. of thirty thousand dollars and due May 1 1901, it is necessary to issue and sell refundonds of Oregon City to the said amount of thirty thousand dollars.

Sec. III. And, Whereas, August G. Klosterman of Portland, Oregon, has offered and agreed to purchase said bonds of Oregon City, agreeing to pay the amount of the principal of said bonds, to wit the sum of thirty thousand dollars together with a pre-mium thereon of two thousand nine hun-

midin thereon of two that hereby ordered dred dollars Sec. IV. Therefore it is hereby ordered that the Mayor and Recorder of Oregon City, Oregon, be, and they hereby are au-thorized, empowered and directed for and thorized, empowered and directed for and on behalf of said Oregon City, Oregon, and for its benefit to issue, execute and deliver to the City Treasurer as hereinafter provided, under the seal of Oregon City, refunding bonds of Oregon City, Oregon, for the purpose aforesaid in the aggregate amount of thirty thousand dollars [\$30,000,] consisting of thirty [30] bonds of one thou-sand dollars (\$1,000,) each, numbered from and donars (\$1,000,) each, him bered from one to thirty, inclusive, said bonds to be dated May 1, 1901, and payable in twenty [20] years after date thereof, and to bear in-terest at the rate of five per centum per an-num, payable semi-annually, on the 1st days of May and November of each year, the sev-oral installments of interest to be avidenced eral installments of interest to be evidenced by forty coupons attached to each of said bonds, both principal and interest to be payable at the office of the City Treasurer of Oregon City, Oregon Said bonds and coupons shall be in lawful form, and shall contain the provision that both the princi-pal and interest of said bonds shall be payble in Gold Coin of the United States of America of the present standard of weight and fineness. Said bonds shall be made payable to bearer and the faith and credit of Oregon City is hereby pledged for the punctual payment thereof. Sec. V. Upon the presentation of said

Sec. V. Upon the presentation of said interest coupons to the City Treasurer at or after their maturity he shall pay the same out of any funds he may have applicable thereto, and they shall take precedence and be paid before any outstanding city warrant or other obligation of said Oregon City. Sec. VI. Upon their execution the Re-corder shall deposit said bonds with the City Treasurer who shall retain said bonds in his possession and not deliver the same or any of them until after he has paid and

or any of them until after he has paid and cancelled the said thirty thousand dollars of outstanding bonds of Oregon City due May 1, 1901.

Sec. VII. After the payment and cancel-lation of the said thirty thousand dollars of outstanding bonds of Oregon City due May 1, 1901, and upon the payment to the City Treasurer of Oregon City of the sum of thirty two thousand nine hundred dollars (\$2500,) by August G. Klosterman, of Portand, Oregon, the said Treasurer shall issue and deliver to the said August G. Kioster-man the thirty thousand dollars of refund-ing bouds of Oregon City provided for in Sec. VIII.
