Semi-Annual Report of Board of Water Commissioners.

Mechanical System of Filteration by the Gravity Process Adopted For a Pure Water Supply

OREGON CITY ORDEN, July 1, 1901. cil of Oregon City, Oregon.

To the Honorable the Mayor and City Connoil of Oregon City, Oregon. Gentlemen: We here ith respectfully submit our semi-annual report of receipts and disbursements of the finances of the City water works. The earnings show a steady increase, and should reach the \$5000.00 mark by the end of the year. Seven new tappings have been made. The principal expenditures, aside from the ordinary expenses, were for a new 20-inch two piy leather belt \$103.38 and a new floor in the station costing \$64.75.

The past six months mark an eventful period in the history of the City Water Works, The past six months mark an eventual period in the history of the City water works, in the fact that at last the Board has decided upon plans for the improvements of the water supply, by means of mechanical filteration. In our last report we gave the Conneil the result of our investigations regarding a gravity supply, but as the expense secured beyond the income from the water revenues, to take care of interest and oper ating expenses, this supply was dropped, for at least a few years to come. Steps have already been taken to have the Forest Reserve on the South fork of the Clackamas river set aside for the furure need of our city water supply. The propositions considered are as follows:

The propositions considered are as follows: FIRST-A gravity system from the Clackamas river to our present pumping station was, after a careful survey by the City Engineer, found impranticable, as the fail is but by new to the pumps at a distance of 515 miles, and the expense, at least 40 to 60 mousand dollars, and the trouble of having moddy water during freshets.

SECOND-Plans to place the pointing station at the Clackamas river, and pump direct to reservoirs. Coat of a so table plant with the necessary mains was estimated, roughly, at \$70,000 and if steam, the cost of operation would be from \$500 to \$000 per munth. Water power might be obtained, but taking the sast experience of Mr. Cross and the old Paper Mill Co., it is not considered reliable, without a large expenditure of

THIRD-The proposed gravity supply from the south fork of the Clerkamas river, in the Forest Reserve, 26 miles from the reservoir. This stream would give ample supply for a city of 20,000 and the water is the equal of the Bull Run furnished to Port-land. The lowest estimate places the cost at \$150,000 but with the improvements that

land. The lowest estimate places the cost at storoto but with the improvements that would be necessary, it would probably be as high as \$300,000. FOURTH — A gravity supply from Gards Surings, 12 miles south east of the reservoir, was thereagly prospecied prior to investigating the South fork of the Clackamas, and found undesirable owing to the fact of there being barely sufficient water for present needs, and no opportunity to increase the supply for future demands. F(FTH—Lastly it remains for mechanical filteration to provide an efficient and

economical means of furnishing pure and wholesome water from our present supply. The board was first informed of this system in 1896, but owing to the financial stringenry and the expense attending the new reservoir, the matter was not considered seriously. In our July report for 1880 the Board stated that a representative of the California In our July report for loss the Board stated that a representative of the California Jewell Filter Co, had looked over our proposition, and stated that at a cost of not to ex-ceed \$25,000 a filter plant of one million gallon capacity in 24 hours could be installed. As the sentiment of a large proportion of the citizens were exposed to such large ex-penditure for a gravity system, with the prospect that the income might not take care of the same for some time to come, it was then decided by the Board to investigate the filter system in a thorough matner, and to that end had the California Filter Co, of San Francisco, brings an experimental to require filter to the cit. Francisco, bring an experimental pressure filter to the city, and make a practical de-monstration of the merits of their system The same was placed on Seventh and Main streets, during the latter part of March, and a thirty day test required. On the 12th of April samples were taken and sent to Prof. F. L. Washburn, the state biologist at the University of Eugene, and also to Prof. A. L. Kinsley, chemist at the Oregon Agricul-tural college at Corvalis, for analysis; the results of their examinations were highly satisfactory, from the fact that the water in the river was quite moddy at the time, and It proved that the filter, while making the water clear and coloriess, it removed all the foreign matter except a very small percentage of bacteria. Refore considering a proposition the Board addressed a circular letter to 20 different cities in the United States which are using filters of the capacity we require. We re-

ceived answers from the following 12: Vease, Maine, Conneaut, Ohio, Royersford, Pa., Charlotte, N. C., Raleigh, N. C., Wolfield, Kansas, Oswego, New York, Morgantown, W., V., Reading, Mass. Columbos, Misr, Mt. Clements, Mich, Athens, Georgia. Reports from all of these cities state that the results are highly satisfactory. The obsaper cost is mainly a saving of freights. The experimental filter is still kept running, for the benefit of the public, and gives a

very satisfactory drinking water. Better results can without doubt be obtained from the gravity system of filters using filtered water to wash the filter bed with. Contrary to the belief of many people, the river water the time it was analyzed was quite muddy, but was not considered unfit for driuking, consequently to free it from all suspended matter would be a great benefit, which filteration does. The cost of making this filter test was \$17 and the Board is certain that the knowledge gained, both for themselves and the citi-zens, justifies the expense. The simplicity of cleaning these filters is one of their chief

The board has closed a contract with the California Jeweil Filter Company of San Prancisco, Cal. to erect a lewell gravity filter plant capable of filtering one million galions of water in each 24 hours, under a guarantee to make clear, colorless, octorless and 97 per cent free from organisms and basteria, for the sum of \$12,700.00. Buildings, foundations, connecting mains, etc. are not lociuded.

The Board has employed an engineer to make plans for a suitable intake pipe to extend up the basin, and into running water, and do away with the bad water caused by filth and mud that is constantly sirred up in hasin whenever the boats come in. After considerable trouble the old Coment Mill, 50x150 feet, has been purchased and will prove a very desirable place for the fifters after the removal of the present structure.

The total cost of the filter plant, land, buildings, foundations, mains, intake pipe etc expected to be within \$25,000 and will be installed within the next four months. A . A1 Is expected to be within parameters in and, the total debt on the Water Works will be this price deducting the amount on hand, the total debt on the Water Works will be almost \$25,000 and as the extra cost of operation will not be more than \$00 or \$70 per month, there will remain from three to five thousand dollars per year to apply on the debt, which with an increase of revenue to be expected from PURE WATER, promises


