Hon. Gordon E. Hayes made a rousing address to the convention while the committee on credentials was deliberating. Is is speech was greeted with cheers and applause. He paid a glowing tribute to Lincoln.

State Senator George C. Brownell was called and made a sturring address. He advised an equally distributed ticket over all the county. His speech was enthusiastically received. He alluded to the promises made and fulfilled, and spoke of the work accomplished in the legislature. He challenged the opposition to show where the party had neglected to perform all the pledges made in the platform two years ago. He promised to work for an 8-hour-a-day law and to endeavor to have railroad mileage reduced from four to three cents per mile. He spoke of the great honor and privilege of being permitted to be an instrument for the election of Senator John H. Mitchell.

Election of permanent chairman.

We demand a constitutional amendment for the election of United States Senators by direct vote of the people. Believing, as we do, that all people should participate as far as possible in the making of the laws by which they are governed, we heartily indorse and

commend to the careful consideration of all the electors, the constitutional amendment known as the initiative and referendum, and urge upon all speakers and campaigo workers to bring the matter prominen'ly before the voters.

We endorse the action of the members of the last legislature in supporting Hon. John H. Mitchell for the United States Senate.

We commend the action of Senators Brownell and Porter and Representatives Kruss, Talbert and Dresser for their sot port of what is known as the precinct assessor law, and the passage of the thirty days exemption law for the wage earners of the State of Oregon, and their action in refusing to raise county saluries, We instruct the nominees of this couvention to both branches of the legislature, that if elected, they will make an earnest effort to obtain legislation which will cause control of the school textbooks by the State of Oregon and their sale to the people at actual cost.

To obtain legislation by which a portion of the State revenues may be raised by a graduated income tax and a graduated inheritance tax.

To obtain legislation reducing the passenger fare in the State of Oregon to three cents per mile.

To obtain legislation constituting eight hours a day's work throughout the State.
