All that is new about the proposed Initiative and Referendum in Oregon is the extension of the direct power of the people over practically all state and local laws. The principal is old, even in this State, in purely local matters, except that it has been always necessary to get a special act or the consent of the legislature.

Since 1885, one hundred voters by their Initiative petition filed with the county clerk, have been able to compel a vote in their county on the question of wine running at large. See section 3416 Oregon Code. In 1893 this law was amended to make the Initiative petition apply to stock of all kinds. Session Laws 1893, p. 89.

Upon the Initiative petition of twenty-five taxpayers, the question of accepting the public park law of 1890 must be submitted to the citizens in cities of not less than three thousand inhabitants. Laws 1890, sec. 1, page 68. The question of a special tax levy for park purposes must be decided by Referendum vote. Laws 1890, sec. 6, page 70.

There are other examples in our laws, but they are all local, and under powers conferred by the legislature. The Initiative and Referendum amendment to the Constitution of Oregon is intended to give to a reasonable number of the citizens, as well as to the legislature, full power to alter a law submitted or referred to all the voters at any general election. All the expense must be paid by the petitioners, except the cost of printing the question on the regular ballot.

HAIR OF THE SLOTH.

It is Green in Color and For a Singular Reason. It is a very curious fact that certain plants grow and thrive on the hair of sloths. Apart from its extremely coarse and brittle nature, the most striking peculiarity of the outer hair of the sloth is its more or less decidedly green tinge. Now, green is a very rare color among mammals, and there are therefore, to be some special reasons for its development in the sloth, and in this coloration is produced by the most marvelous phenomena in the whole animal kingdom, so marvelous indeed, that it is at first almost impossible to believe that it is true.

The object of this peculiar type of coloration is, of course, to assimilate the animal to its leafy surroundings and thus to render it inconspicuous, as possible, and when hanging in its usual position from the underside of a branch its long, coarse and grating hair is stated to render the almost indistinguishable from bunches of gray green lichens among which it dwells. In the outer sheath of the hairs of the sloth there are a number of transverse cracks, and in these cracks grows a primitive type of plant—namely, a one celled alga.

And for the benefit of nonbotanists readers it may be well to mention that alga, among which seaweeds are included, form a group of flowering plants related on the one hand to the fungi and on the other to the lichens. In the moist tropical forests of the home of the sloths the alga in the cracks of their hairs grow readily and thus commensurate to the entire body that general green tint which, as is readily said, is reported to render the almost indistinguishable from the stems of lichen among which they hang suspended.—Knowledge.

THE FATE OF CORONETS. Lord Brougham's Became a Child's Fruit Dish. Peers and their coronets are spared when the ceremonial has been served. The fate of one coronet is told by a correspondent of M. L. F. He writes: "When I was staying some years ago in Philadelphia with G. W. Childs, the well known proprietor of the Ledger newspaper there, I sat at dinner one evening a peculiarly shaped glass stand used as a support for china dish containing grapes. My observation that I was scanning it intently, said: 'Oh, that is the coronet of Lord Brougham taken at the coronation. I have taken out the velvet cup and turned it upside down. The golden balls form excellent food and it makes a most elegant stand.' What it certainly did!

But what is the fate of coronets compared with the fate of coronets robes? A large portion of George IV's wardrobe, including the coronets robes, was put at public auction in the summer of 1831. There were 129 robes disposed of, and some of the items are interesting. A pair of fine blue broad of ample dimensions and lined with white satin, was sold for 12 shillings. The sumptuous crimson velvet coronet mantle, with silver star, embroidered with gold, which cost originally according to the auctioneer, £200, was knocked down for 47 guineas; a rich embroidered silver tissue coronet waistcoat and trunk hose, £15. The purple velvet coronet robe, embroidered with gold, of which it was said to contain 200 ounces, brought only £12, although it cost his late majesty £200. An elegant and costly green velvet mantle, lined with ermine of the Empress Alexander to George IV., which cost 1,000 guineas, was sold for £125.

A Singular Request. A peculiar fate is said to overtake the family of the late Sir Julian Goldsmid. An ancestor of his, so says legend, once gave shelter to a rabbi who, at his death, left to him a bag of a mysterious box, which was to be opened only after the customary seven days of mourning. Curiosity got the better of superstition, and the box was opened before the seven days were up. In it was found a document which said that the injunction of the rabbi had been heeded no future owner of the estate would be succeeded by a son. And such, strangely enough, has been the case ever since.
