There will be a joint teachers meeting held on the 15th of this month, of the teachers of Multnomah and Clackamas counties.

The receipts in the county departments for the month of October showed a great increase over previous months, Recorder Stevens having collected \$289.20, while Clerk Sleight collected \$357.10 during the month.

The Daughter's of the King will hold a festival on December 5, in this city. The affair will be novel in the extreme and a good time is promised. Full particulars will be given later through the columns of the city papers.

Notwithstanding the fact that the tax rolls were closed, there is some tax money yet being collected by the sheriffs. The extent of these collections is small, as a matter of fact, but delinquents continue to drop in occasionally.

Sunday's heavy rain caused considerable damage to the fish racks in the Clackamas river, which threatened to take out the fish racks in that stream. The river raised several feet in a few hours, and it was by only the greatest effort that the racks were saved.

W. O. Tycer, an ex-member of Company I, Second Oregon volunteers, died at the home of his brother in Gladstone, Sunday. His death was the result of ailments contracted in the Philippines, which developed into consumption. When in the service he is said to have made a good record. His remains were taken to Brownsville for burial.

Maple Lane Grange has just purchased an acre of land for a site for a large and commodious hall, which it is expected to soon erect. To start a fund for this purpose the ladies of the grange will give a pie social at Nash's hall, on Saturday evening, November 15, to which the entire public is extended a most pressing invitation.

The ministers of the city, forming the Ministerial Association, met at the Y. M. C. A., Tuesday. Rev. Hammond was elected president, and Rev. Mizell was received as a member. Arrangements were made for a union Thanksgiving Day service, to be held at the Presbyterian church at 11 a. m., Rev. Grimm, of the Methodist church, to preach the sermon.

The Junior class at the Y. M. C. A. has been divided into two squads and are contesting for points in soliciting and gaining new members, and in gymnastic contests and good conduct. This contest is to continue until the first of February, when the winning side will be banquetted. The individual making the best showing will be awarded some token. A framed pennant will be hung in the parlor as a memento of the contest.

Three men, loggers, had considerable of an experience last Saturday, near the electric plant, on the other side of the river. The men were in a row boat, and were gliding along, not apprehending any danger, when the boat was struck by a cross current, which carried it under a scow near by. Two of the men clung to the scow, while the other one stayed by the small boat, and was given a good wetting. He was carried 50 feet under the scow, but came out apparently none the worse for the wear.

The members of the militia company have their gymnasium at the armory about ready for use, having added gradually to its equipment until it is now very complete, a fact much appreciated by those who are privileged about the place. The gymnasium will be open each evening, but will remain closed on Sundays. While the gymnasium is for the use and pleasure of the militiamen, each member has the privilege of inviting a friend to enjoy what is afforded in that line at the armory.

Mrs. Hannah Frederick died in this city last Saturday, of pneumonia, after an illness of about ten days, at the age of 64 years and three months. Deceased came here with her husband nearly two years ago from Alexandria, Minn., where she had resided since 1856, having been married to F. W. Frederick in that place in 1857. Mrs. Frederick was a sister of Josiah Martin, who has been a resident of this city for many years. An invalid husband and five grown children survive. The remains were laid to rest Monday in Mountain View cemetery.

Mrs. George C. Brownell entertained the Young People's Society of the Presbyterian church, Halloween at her home in this city. About 60 guests were present, and the evening was most pleasantly spent in games appropriate to the season. Several young ladies attired as ghosts greeted the guests upon arrival and furnished some weird music later in the evening. The rooms and grounds were lighted with grotesque jack-o'-lanterns. Refreshments were served in an odd and amusing way and a very social evening was passed.

The county court had a very perplexing question before it Wednesday, when the people of Milwaukie, or twenty-three of the property owners down there, presented to that body a contest against the election and incorporation of that place which occurred on the 25th of last month. These people claim an illegal election and allege other things in regard to the proceedings. The court will not likely declare the election an illegal one, however, the matter may be taken to the circuit court. Meantime the officers of the new city are going on about their public business as though nothing had happened.
