WHAT WILL WEATHER BE?

Data for Month of June Compiled by Forecast Official.

The following data, covering a period of 21 years, have been compiled from the weather bureau records at Portland, Or., for the month of June.

TEMPERATURE. Mean or normal temperature, 62 deg. The warmest month was that of 1880, with an average of 69 deg.

The coldest month was that of 1893, with an average of 55 deg. The highest temperature was 99 deg. on the 17th, 1896.

The lowest temperature was 39 deg. on the 4th, 1875; and on the 6th, 1899.

Average date on which first killing frost occurred in autumn, Nov. 15. Average date on which last killing frost occurred in spring, March 17.

PRECIPITATION (Rain and melted snow.) Average for the month, 1.74 inches. Average number of days with .01 of an inch or more, 10.

The greatest monthly precipitation was 5.38 inches in 1888. The least monthly precipitation was 0.08 inches in 1883.

The greatest amount of precipitation recorded in any 24 consecutive hours was 1.85 inches on the 17th, 1873.

The greatest amount of snowfall recorded in any 24 consecutive hours (record extending to winter of 1884-85 only) was .01 inches on 4th, 1895.

CLOUDS AND WEATHER. Average number of clear days, 8; partly cloudy days, 10; cloudy days, 12.

The prevailing winds have been from the northwest. The highest velocity of the wind was 53 miles, from the south, on the 23, 1894.

What Clackamas County Roads Have Cost.

Cash Road Tax Has Been Raised and Nearly a Half Million Dollars Expended in Ten Years.

EVANS UNNECESSARILY EXCITED

Deputy Health Officer Mistaken About Smallpox—Only One Case.

Dr. J. W. Powell has returned from the vicinity of Sycamore, where, as Clackamas county physician, he made a thorough investigation with reference to the alleged existence of smallpox within the borders of this county "to an alarming extent." Dr. Powell reports that he visited the district between Damascus and Sycamore, where it is claimed there were thirty cases of the disease. He found but a single case and that one is in the family of Henry Trognor, a young boy, who was only mildly afflicted. No new cases are developing and he is satisfied that the disease has been exterminated. Clackamas county officers feel that they have received a greater amount of criticism in connection with the smallpox cases than actual conditions warranted.
