### SHERIFF SHAYER IN POSSESSION.

Refuses to Surrender Howard Grocery Stock to Assignee.

Sheriff Shayer refuses to surrender to Judge T. F. Ryan, as assignee, the papers, stock and fixtures of Geo. T. Howard, the groceryman of this city, who recently suspended business in this city. And therein lies an interesting legal question that will be unravelled by Judge McBride who is convening circuit court in this city Thursday.

Wednesday, June 24, Sheriff Shayer attached the grocery stock of Howard's on an action for money suit brought by M. Michaels. The sheriff took possession and retaining in charge of the property. Last Friday, July 3, Mrs. E. J. Howard, exercising the power of attorney that had been vested in her by Howard, her husband, made an assignment of the stock and business to Judge Ryan for the benefit of the numerous creditors of the estate. But Sheriff Shayer refused to deliver the keys. Tuesday Judge Ryan served written notice on the sheriff that he would be personally held responsible for all losses and depreciation in value that may attend his actions. In view of this, C. D. and D. C. Latourrette and M. Michaels, M. Michaels, who are among the principal claimants against Howard, filed a bond in the sum of \$8000 for the protection of Sheriff Shayer. Judge Ryan holds that the making of an assignment in regular form dissolves any pending writ of attachment that may have been issued prior to that time. Messrs. Latourrette and Michaels hold the opposite view and allege that the assignment has been irregularly made.

## MAKE BETTER TIME

Southern Pacific Company Contemplates Important Change.

Expects to Reduce by Twelve Hours the Time Between Portland and San Francisco.

A press dispatch from San Francisco, of recent date, says: During his recent visit to California, President Harriman planned improvements and innovations on his Southern Pacific system which will keep officials of the traffic and operating departments busy for many months.

One of his plans is to shorten the time between San Francisco and Portland, and improvements to that end are now going on. Traffic officials believe that the time may be cut down half a day, and the distance covered in 27 hours.

On the northern mountain divisions preparations are being made for a faster schedule. Reconstruction is progressing rapidly. Curves are being reduced and grades done away with wherever possible.

Heavier rails are being laid, and the company is now receiving shipments of an order for 25,000 tons of 80-pound steel rails, or sufficient to lay 200 miles of track. The lighter rails which the new ones will replace are still in good condition and will be laid on the small branch roads of the system.

One step in the work of shortening the time on the northern route has just been accomplished. Arrangements are about completed for the introduction of oil as fuel on the entire California system, and the great oil tanks on the northern divisions are ready for use. The operating department has been engaged in effecting the abolition of coal for some time. It has involved the erection of a large number of storage tanks at different points.

Last Thursday morning it was stated in the office of the operating department that as soon as the few requisite changes are made in the coal-burning engines the recently constructed oil tanks on the company's Northern California lines, which are being stored with liquid fuel, will supply the engines on the northern divisions.

The great tank at Ashland, Oregon, capable of holding 55,000 barrels of oil, has just been completed; and those at Hornbrook and Edgewood, with capacities of 15,000 barrels each, are practically ready for use. At Dunsmuir another 55,000 barrel tank has been recently erected. One of the largest tanks on the system is at Red Bluff, with a capacity of 85,000 barrels of oil.

### CELEBRATED IN DRIZZLING RAIN.

Rain Seriously Interfered With the Exercises of the Day.

A constant drizzling rain prevented the carrying out of an elaborate Independence day celebration in this city. Because of the inclement weather, the oration of Hon. B. L. Eddy, of Tillamook, was omitted from the programme of the day, as was also the ball game between the Monograms, of Portland, and the Oregon City nine.

The day's festivities concluded with two grand balls. But for the unfavorable weather the attendance in this city Saturday would have been without precedent. The fireworks that had been purchased for the celebration were set off Wednesday evening of this week.

Prohibited from the use of giant firecrackers, bombs and Dewey chasers by city ordinance, the youthful celebrators of this city resorted to the use of pistols with blank cartridges and deafening torpedoes, with which constant confusion was produced. No serious accidents occurred.
