

CLACKAMAS COUNTY FAIR

Resolution Passed Looking to the Establishment of Such an Institution

SCORE JUDGE GALOWAY

Eagle Creek Grange Publicly Thanked For Its Hospitality—Place of October Meet Not Chosen.

Eagle Creek, July 10.—The Clackamas County District Pomona grange met in the hall of the Eagle Creek grange this morning at 11 a. m. One hundred and two members were present at 1 o'clock. Reports from the subordinate granges of the county showed a prosperous condition. The Eagle Creek grange set tables for dinner and supper with the best of skill of the housewife could produce.

Four new resolutions were introduced. One protesting against the killing of the referendum by Judge Galloway was introduced by F. M. Gill. He also introduced a resolution asking a change of the method of distributing the school moneys from the per capita system to the days attendance and that \$100 be given each district instead of \$50 as now. After a lengthy discussion Mr. Gill moved that a committee of three be appointed to investigate the subject and report at the October meeting. This committee is F. M. Gill, R. A. Wright, and Mrs. Maggie Johnson, of Estacada, Mullins and Milwaukee, respectively.

The resolution of protest against Judge Galloway's decision and adopted by nearly a unanimous vote reads as follows:

Whereas the Constitution of Oregon provides that upon a petition signed by five per cent of the voters who voted for supreme judge at the preceding election any bill adopted by the legislative assembly shall be presented to the people for their sanction or rejection at the next election, and,

Whereas, four such petitions have been duly signed and presented to the secretary of state as the spirit and purpose of the Constitution provides, and

Whereas, on purely technical grounds and in direct opposition to the intent and purpose of the Constitution of the State of Oregon, Judge Galloway has set up his opinion against the will of the people who are exercising a right granted them by the Constitution, thus defeating the will of the people;

Be it resolved by the Clackamas County District Pomona grange that we condemn the action of Judge Galloway with all the earnestness that we possess and ask the executive committee of the State Grange to appeal from his decision to the Supreme Court of the State.

The following resolution introduced by A. J. Lewis of Maple Lane grange was unanimously adopted:

Whereas, there is a fund in the county for the purpose of exploiting the resources of our county, and,

Whereas, we believe that this fund cannot be better employed than in holding a county fair, therefore, be it Resolved, by this District Pomona grange that we petition our county

court to grant the said \$500.00 to an association for the purpose of holding a county fair, and be it further

Resolved, that the master of this grange appoint a committee of five to co-operate with any other committee laboring with this end in view.

The following resolution introduced by H. F. Gibson of Eagle Creek was adopted by a unanimous vote:

Whereas, the history of labor unions, bankers' associations and other similar associations shows that to be successful in co-operation each interest must unite for its own protection, be it

Resolved by Clackamas District Pomona grange that we believe that fruit growers, potato growers, onion growers, etc., to successfully co-operate should each form an organization to work for their several interests.

The committee on resolutions was A. J. Lewis, George Ogle, and Margaret L. Roberts.

Master J. W. Thomas appointed A. J. Lewis, chairman, O. D. Robbins, of Logan, Mrs. Maggie A. Johnson of Milwaukee, George Lazelle of New Era, and William Cristhenwaite of Beaver Creek as the committee on county fair.

Harrison Tracy and Norman Tracy each had a fine display of Bing cherries on exhibit at the front of the hall. One of them measured 3 3/4 inches in circumference. Edwin Bates displayed some fine Royal Annes, while D. M. Marshall displayed some large Oregon cherries.

A class of twelve was initiated into the fifth degree of the order.

An excellent program was rendered under the charge of Mrs. Maggie Johnson. The program was as follows: Song, Eagle Creek grange; recitation, "The Village Oracle," F. M. Gill; reading, Freda Duns; reading, by Mrs. Maggie Johnson, of an essay written by Mr. Dobbins of Milwaukee; reminiscences of the Civil War; song, Eagle Creek grange; reading, Mr. Johnson of Milwaukee, "The Mishaps of a Boy"; song, "America."

A vote of thanks was extended to Eagle Creek grange for its hospitality. The October meeting will probably be held with Clackamas grange at Clackamas.

CLAIMS LOGS IN HIS POSSESSION

The Willamette Pulp and Paper Co. has instituted a suit against G. L. Read for the recovery of seven saw logs, four spruce and three cottonwood, containing 5,210 board feet and valued at \$41.68.

These logs are branded with the company's mark, a W enclosed in a diamond, the points of which are broken off. The logs have been anchored on the defendant's property. The complaint alleges that Read has been warned to release them, but he still retains possession.

The plaintiff asks the possession of the logs or their equivalent in cash, \$50 damages and costs of suit.

COMMITTEE OF FIVE NAMED

The charter commission, named to draft a new charter or materially change the present Oregon City charter, is composed of 25 members. Recently the chairman, Mayor Caulfield, was authorized to appoint a new committee, to consist of himself and four others, who are to do the active work of the revision. Those named are W. S. U'Ren, Frank T. Griffith, Judge T. F. Ryan and J. U. Campbell.

The committee has sixty days in which to draft a new charter and report to the committee at large.

PARKPLACE BRIDGE NEARLY COLLAPSES

TEN TON PIPE AND SIX HORSES TOO HEAVY FOR OLD STRUCTURE.

A 10 ton iron pipe, hauled by six horses proved too heavy for the Park place wagon bridge Wednesday evening. The supporting timbers parted and the load, horses and driver narrowly escaped a fatal drop to the stream. The break was so bad that the bridge was at once closed to traffic by the order of the county court.

The court has ordered the bridge rebuilt, all new timbers being used together with the old iron. This will cost about one-third what an entirely new bridge would cost and give a structure practically as strong. The timbers are being hauled to the scene and it is thought the bridge can be reopened for traffic in four or five days.

The Parkplace bridge has been in a bad condition for several years. The north approach looks as though it might fall at any minute.

An entire new bridge, at the present high price of iron would cost about \$9000. A concrete pier would be necessary and it could not be put in for less than \$1000. The present bridge has a span of 170 feet.

The bridge at Estacada is also in a dangerous condition, and County Judge Dimick says that this structure will be replaced by a new one as soon as possible.
