Theodore Roosevelt, Jr., son of the President of the United States, has become a full-fledged member of the order of boxing fans. At Chelsea, Mass., Freddie Welsh, of England, met Dave Desher, New England's best lightweight, and young Teddy sat at the ringside. Thinking Welsh was overmatched, the President's son cast his sympathies with the Englishman. The Briton fought a splendid battle and gradually wore down Desher, and by his clever ring tactics had him helpless in the final rounds.

Teddy, Jr., visited Welsh's room after the bout and asked to be presented to the young Englishman and his second, Lew Bailey, the Philadelphia boxing promoter.
