

HOPE OF POTATO DEMAND VANISHES

All hope of any material improvement in the potato market has passed. The season is now so well advanced that it would be impossible to move the entire crop in many sections of the Pacific Northwest, it is stated, that not more than half of the crop has been dug. Prices are so low that producers say it does not pay to dig them.

POTATO PRICES ARE STILL AT LOW EBB

The weakness in the potato trade and the slowness of the demand, coupled with the fact that country interests are overloading the trade is worrying the commission men. In the Portland trade there has been a fair movement of potatoes recently, but for every sack sold there have been three more received recently. Naturally, this has not had a good effect upon the trade. Receivers are unable to find room for the increased offerings. Their own storerooms are full, the docks are full and the prices are so low that they do not want to take the chance of putting them in public storehouses with the additional cost.

APPLE DEMAND SHOWS INCREASE

Trade in the apple market continued very liberal in Portland Friday. The outward movement of apples is the heaviest ever known although the movement has not in any way affected the price. Reports from the country indicate that stocks are being cleaned up fast. Supplies in some of the leading districts consist principally of Ben Davis, and these are the hardest to sell as they are selling down to 50c a box in the Fruit Street trade, and the movement is restricted.

EGGS SELLING AT 14 CENTS DOZEN

Eggs probably reached the lowest mark Tuesday that they will during the coming year. The price was 14 and 15 cents Wednesday and Thursday in this city. The chances are pretty fair that before many days are past they will again be on the upward grade, as egg merchants have already begun storing. Hens have taken a drop of one half a cent during the past week and will remain stationary for some time.

HOP CONTRACTS ARE IN BIG DEMAND

The market for hop contracts is rather active and firm at 15c a pound. Considerable business has passed at Willamette Valley points during the last few days, the aggregate being the greatest of the season to date. Most buyers have been operators and some of them have purchased extensively. The market for hop goods is very quiet and somewhat inclined to show weakness. The future of the trade depends entirely upon the crop advice. Present prospects are for a good output but the season is still too early to say much regarding this. Many things may happen between now and picking time.
