MEXICO CITY IS IN LINE OF MARCH

REBELS PREPARE TO ADVANCE
ON CAPITAL CITY, SAY
LATE REPORTS

15,000 MEN AT VILLA'S COMMAND

Diplomats Are Seeking to Bring About
Change Without Bloodshed—
Huerta's Flight Momentarily
Expected

MEXICO CITY, July 14.—At 10 o'clock tonight the family of President Huerta and other relatives and close friends left the capital for Vera Cruz aboard a special train. The train was composed of three sleepers and a baggage car. Running ahead of it were two military trains carrying 500 men. Following came another military train with 500 troops aboard.

WASHINGTON, July 14.—Although the resignation of General Huerta is confidently expected by the state department and Washington diplomats to be presented at any moment, the constitutionalists, unaffected by the news, are pressing hard their military campaign on Mexico City.

Official dispatches revealed that General Villa, with 15,000 men, was ready for a rapid advance on the Mexican capital and that General Obregon's forces at Guadalajara were prepared to sweep onward within a few days.

The numerous official advices saying Huerta would resign in a day or two, including messages from the Brazilian minister in Mexico City and other diplomats, have raised the expectations of official Washington that his exit from power also would mean his flight from the country.

Rafael Zurbarán, Carranza's confidential agent here, has received instructions on which to draft a formal reply to the note of the mediators, which proposed informal conferences between the constitutionalists and Huerta delegates for the settlement of internal questions. The constitutionalist generals have expressed their disapproval of the plan, and Zurbarán's instructions, it is understood, are to reject the invitation.

VERA CRUZ, July 14.—That President Huerta and the members of his family who have not already left Mexico City would arrive here this evening was predicted today by men in close touch with developments at the capital. The break in the railroad between there and Vera Cruz had been repaired and there was nothing, except a possible holdup by rebels en route, to interfere with a through trip. Swinging at anchor in Vera Cruz harbor is the "loot ship" Espagne, scheduled to sail for Europe but supposedly held for Huerta, and in the rush of Mexican aristocracy from the capital to board the vessel as their last hope of safety before the collapse of General Huerta, scenes rivaling the most vivid fiction ever written are being enacted here.

DOTY SOLD TO CLEVELAND CLUB

VANCOUVER, B. C., July 14.—President Brown, of the Vancouver baseball club today announced the sale of Pitcher Ed Doty to the Cleveland American League club. The purchase price is understood to be \$2500. Doty will finish the season with the Vancouver club.

Convention Saved for West.

DENVER, July 14.—Substituting their city for Seattle with quick precision, Los Angeles and Southern California delegations swung the annual national reunion of Benevolent and Protective Order of Elks for 1915 back to the Pacific coast when at the first session of the grand lodge today it seemed bound eastward to Chattanooga, Tenn.

ASK COURT TO LET HAL CHASE PERFORM

BUFFALO, July 9.—Attorneys representing Hal Chase, the ball player, today urged United States Judge Bissell to dissolve the temporary injunction granted the Chicago White Sox which prevents Chase from playing with the Buffalo club of the Federal league. Chase jumped from the Chicago club to the outlaw organization last month.

Racing Boat Sinks.

RAINIER, Ore., July 15.—Oregon Kid H. Pacific coast and Columbia river champion motorboat, sank near the middle of the Columbia river off Wallace Island, 18 miles west of her tonight at 6:15 o'clock.

Prohibition Loses.

DES MOINES, July 15.—Prohibition forces lost their battle for the insertion of a plank favoring the re-submission of the prohibition question to a vote of the people at the Republican state convention here today. The convention did adopt a plank endorsing the present liquor laws and commending their enforcement.

Road Bonds Carried.

HOOD RIVER, Ore., July 15.—By a vote of 1652 to 428 the people of Hood River county today authorized a bond issue of \$75,000 for completion of the Columbia river highway in Hood River county. All of the 12 precincts in the county, with the single exception of Dee, a thinly populated district, voted big majorities for the bonds. Tonight the citizens turned out en masse and seldom in the annals of the city has such jubilation been shown over an election of any kind.

Photos Used in Faks.

PORTLAND, Ore., July 15.—Kodak pictures of the famous sequoia, or big redwood, trees of California were used as fake pictures of Oregon timber by J. W. Logan, of Tacoma, in persuading Californians to buy "locations" on timber lands within the Oregon & California Railroad grant in Oregon, according to testimony given in United States district court yesterday by J. D. Safford, a San Francisco chauffeur, who admitted he had been an accomplice of Logan's.

CARRANZA READY TO RUSH INTO MEXICO CITY

WASHINGTON, July 14.—General Carranza had gone to Tampico today, according to messages here from northern Mexico, preparatory to taking a steamship for Vera Cruz in the event of President Huerta's flight from the capital.

WADSWORTH MAY GET ROOT'S BEAT IN THE UNITED STATES SENATE

NEW YORK, July 14.—James W. Wadsworth—"Young Jim"—will probably be the choice of a majority of the Republican organization leaders for the United States senatorship nomination, and it is anticipated that his friends will soon begin a canvass in his behalf, now that Senator Elihu Root is out of the race. William Barnes, state chairman, is expected to favor Wadsworth. Mr. Barnes fought long and hard for the nomination of Wadsworth for governor at the convention which renominated Governor Hughes.

TEMPERATURE CLIMBS TO 107 AT ST. LOUIS

ST. LOUIS, July 11.—Four persons died here today and several others were prostrated by the heat, which broke all records for the year. The clock on the street registered 109 degrees at 1 o'clock.

KANSAS CITY, July 11.—Excessive humidity combined with high temperatures in Kansas and western Missouri today combined to bring much suffering.

ST. PAUL, July 11.—Two deaths and a large number of prostrations due to the heat were reported to the police of Minneapolis and St. Paul tonight.

FATHER IS LECTURED IN JUVENILE COURT

Charged with mistreatment of his own children, A. B. Rosenthal was brought before the juvenile court Monday and severely reprimanded by Judge Anderson.

MISS HOBBS WILL INSPECT PROJECT

LAND BOARD MEMBERS SAY TRIP IS NOT AUTHORIZED BY THEM

SLUR AT MR. LEWIS IS CHARGED

West Asks for Inspection of Big To-male Work—Many Avert That Action is Brand New Political Scheme

SALEM, Ore., July 9.—Miss Fern Hobbs, Governor West's private secretary, left tonight for Laidlaw to make an inspection of the Tumalo irrigation project. She is acting on instructions from the governor, who is lecturing in the east.

State Treasurer Kay and Attorney General Crawford, members of the state desert land board, which has jurisdiction over irrigation work, said they knew nothing about the trip of Miss Hobbs and that they had not authorized it. The state treasurer said:

"I would like to have more direct information with relation to the irrigation project, so I will send one of our young women stenographers to Laidlaw, with instructions to make an investigation of the engineering features."

"I would like an expert statement from her as to whether the big reservoir will hold water."

Asked if the stenographer he would assign to make the investigation would collaborate with Miss Hobbs, Mr. Kay said she would not. He asserted that he wanted his representative to play a lone hand.

"The governor before leaving Salem instructed me to go to Laidlaw and make the inspection," said Miss Hobbs. "He intended going himself, but did not have the opportunity. He wants me to report to him while he is in the east, so he can use the information in connection with matters he has before the departments in Washington."

Attorney General Crawford said the governor had no authority to send a personal representative at the expense of the state to make an inspection of the project. He said the inspection should be made by a member of the state engineering department or an expert employed by the state desert land board. He did not believe a woman, who had not studied engineering, would be competent to do the work.

PRESIDENT FACES DETERMINED FIGHT

WASHINGTON, July 9.—The administration met defeat today in the first stage of its fight to have the senate conform the nominations of Thomas D. Jones, of Chicago, and Paul W. Warburg, of New York, as members of the federal reserve board.

The banking and currency committee voted 7 to 4 to report the nomination of Mr. Jones to the senate with an unfavorable recommendation, and agreed to postpone indefinitely further consideration of the nomination of Mr. Warburg.

The Jones report will be submitted by Acting Chairman Hitchcock early next week, and the debate over his confirmation will be resumed on the floor of the senate behind closed doors in executive session.

M'REYNOLDS ISSUES DEFENSE STATEMENT

WASHINGTON, July 14.—A widening of the breach between the department of justice and the Interstate Commerce commission was though likely here today, as a result of the commission's report, made public Monday, on the result of its investigations of the New Haven railroad under the Mellon regime.

Despite the commission's declaration that the road's directors should be held to criminal account for the manner in which they conducted its affairs and that it was for the justice department to act against them, reporters who asked the department concerning its chief's intentions were answered by a reference to Attorney General McReynolds' letter to Senator Norris when the case was up in January.

This letter declared that there was "no law under which the department can prosecute the New Haven directors for imprudent and dishonest use of the stockholders' money."

Peace Is Prospected.

LONDON, July 14.—Sir Edward Carson was hurriedly summoned from Belfast to London tonight to attend a conference looking to a settlement of the home rule dispute.

A steamer was specially stopped for the Ulster leader, who abandoned general important engagements to rush back to the capital.

Benson Leads.

PORTLAND, Ore., July 14.—After swinging back and forth until first one and then the other had apparently been nominated, the latest complete official figures of the vote for Judge H. L. Benson, of Klamath county, and Judge Charles L. McNary, of Marion county, indicate that Judge Benson has received the Republican nomination for supreme judge.
