

VENGEANCE FOR DEATH OF THREE AMERICANS SWIFT

ONE MEXICAN IS EXECUTED FOR TELLING BANDITS HIDING PLACE OF DOCTOR.

FOUR ARE HANGED TO TREES AND FOUR OTHERS ARE SHOT

Close Watch for Mexicans Maintained for Distance of 100 Miles Up and Down Rio Grande—Officers Withhold Details.

BROWNSVILLE, Tex., Oct. 19.—Ten Mexicans were killed by posse today because of their alleged complicity in last night's wrecking of a St. Louis, Brownsville & Mexico passenger train and the slaying of three Americans and the wounding of four others.

The first Mexican killed was an unidentified young man, a passenger on the wrecked train, who was accused of revealing the hidden place of Dr. F. S. McCain, deputy state health officer here, who took refuge in the lavatory of the car when the bandits began firing.

Sheriff W. T. Vann, of Brownsville, denied reports of this Mexican's death, but tonight it developed that those killed the man after the sheriff left the scene of the wreck. This Mexican was himself threatened by train robbers because of his unusually fair complexion, but was not molested after he told them where two of the "gringos" whom they were hunting, had hidden.

Only the bare facts of the killing of other Mexicans today were obtainable, as the posse were careful not to give out details. The second Mexican killed was alleged to be a "partner" of the young man on the train. The vague remains of the word "partner" was not made clear. Four Mexicans were hanged to trees at various points and four others were shot.

The most reliable information indicated that these shootings were on, or very near the banks of the Rio Grande, where the closest watch for Mexicans was maintained for a distance of 100 miles, up and down the river.

BURNED IN ALASKA FIRE VALLEJO, Cal., Oct. 15.—Gunner J. Holton, machinist's mate, first class, S. S. Sjavakoski, and David Barry, a Mare Island cooper, were badly burned in a fire that destroyed the Cordova wireless station, Alaska, last night, according to radio advices received at Mare Island today. The fire was caused by an alcohol tank exploding.

ESTACADA MARSHAL TUMBLES THROUGH PORTLAND SKYLIGHT

PORTLAND, Ore., Oct. 18.—Plunging through a skylight in the Williams lodging house, Sixth and Stark streets, A. J. Ames, city marshal of Estacada, dropped into the office of the L. & H. saloon, 226 Stark street, at 9 o'clock this morning, and narrowly missed striking several passersby.

Extortioner Shaffer and Jeff Thompson, who investigated the case, says that Ames came to Portland a few days ago from his dry precinct in Estacada and started to make up for lost time. He had a room in the Williams etc. Evidently he started to seek fresh air when he stepped on the skylight which gave way under his weight and he shot downward about 20 feet.

FEW CATTLE SOLD AT PORTLAND YARDS

HEAVIEST RECEIPTS ARE IN HOGS WHILE THERE ARE NO MUTTON ARRIVALS.

UNION STOCK YARDS, Portland, Ore., Oct. 18.—So far as the general situation was concerned there was no change in the livestock market for the day. With the exception of a small bunch of cattle, the arrivals consisted entirely of a hogs.

Top hogs sold this morning in the local market at 7 1/4 or the same price as similar quality brought yesterday. There was only a small supply of cattle reported in the yards overnight and these were of indifferent quality.

While the demand for extreme quality cattle continues good at North Portland with top steers around \$5.55, the poor stuff is still showing nothing but neglect.

While there were no arrivals at all in the mutton trade, the situation is very strong although no change in the price from that reached yesterday is indicated.

All the big killers are purchasing their full requirements direct in the country and are therefore not bidding for the limited volume of stuff that has come forward of late to the local yards.

CROWN WILLAMETTE MILLS REGAIN OLD AUSTRALIAN TRADE

FIRST ORDER SHIPPED FROM CAMAS PLANT IS FOR 2000 TONS OF PAPER.

For the first time in more than a decade Oregon paper mills are shipping their products to Australia.

An order for 2000 tons of newsprint has just been filled by the Crown Willamette Paper company for newspapers and wholesalers in Sydney, Melbourne and other Australian cities.

The order has been filled at the company's plant at Camas, Wash., and the paper brought to Portland for shipment.

The paper is put up in both rolls and sheets, and is understood to be of the nature of a trial order. It is expected that other and heavier orders will follow.

In former years the paper mills in this territory did a heavy business with paper consumers in Australia. On account of the lack of adequate shipping facilities, however, this business was lost and the Australian people began to buy their paper in Europe. The war now has forced them back into the local market, and the mills in this territory are eager to regain their trade.

It is said that Australia offers a fertile field for the output from the local mills, and that a heavy volume of business can be developed there in dependable service can be obtained.

In the absence of regular steamship service to Australia, it is feared that the local mills may not be able to retain the trade of that country.

TOKIO, Oct. 14.—Departure of the liner Mongolia today for San Francisco marked the withdrawal of the Pacific Mail steamship company from the Oriental service. The Mongolia, the latest vessel to fly the stars and stripes in the trans-Pacific service, will go to New York after delivering its passengers and cargo at San Francisco.
