

DELINQUENT TAX LIST

CLACKAMAS COUNTY

This advertised list of delinquent taxes for the year 1914 is in pursuance of an act of the State Legislature, which is embodied in Chapter 301 of the General Laws of the 1913 Session.

The taxes on the following advertised real property became delinquent on the first day of October, 1915, and are subject to a penalty of 10 per cent penalty and interest at the rate of 12 per cent per annum from the first day of October, 1915, until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following real property are delinquent, the sheriff is authorized upon demand of any person making application, to issue to them a certificate of delinquency upon payment of the taxes, penalty and interest and costs of advertising.

Certificate of delinquency shall bear interest from the date of issuance until redeemed at the rate of 15 per cent per annum.
