This is a rather liberal price in view of the fact that offerings of California beans are increasing materially with sales of green stock generally at 11% cents a pound and wax at 10c a pound. Oregon peas are also in larger sup-

ply but the demand is quite good with sales along the wholesale way at 6% @ 7c a pound. California stock is still arriving but it is not of quality to be compared with local offerings.

Local head lettuce is in larger supply and as no further shipments are expected from the south this will supply the wholesale trade during the remainder of the season.

Sharply higher prices for lemons are being quoted in Cattfornia and are reflected in the local trade as a result of the recent damage in the south by hot winds. Much of the stock dropped from the trees.

Further lowering of prices for canta loupes is showing in the local trade with heavier offerings from the south and lower prices there. The extreme top for standards during the day here was \$3.75 per crate.

With a fight on for supplies from houses catering to the Puget Sound trade, an advance of %c a dozen is being quoted in some quarters for case count ages at 30%c. Market along the street is unchanged.

Market for country killed calves has again turned steady along the street with extreme top quality at 15c. This is the only branch of the trade that is showing strength, poor stuff and heavy weights being slow.


