

DELINQUENT TAX LIST

CLACKAMAS COUNTY.

This advertised list of delinquent taxes for the year 1916 in pursuance of an act of the State Legislature, which is embodied in Chapter 266 of the General Laws of the 1917 session.

The taxes on the following advertised real property became delinquent on the 6th day of October, 1917, and are subject to a penalty of 5 per cent after November 5, and interest at the rate of 12 per cent per annum from the 6th day of October, 1917, until they shall have been paid.

Any day after the expiration of six months after the taxes charged against the following real property are delinquent, the sheriff is authorized upon demand of any person making application to issue to them a certificate of delinquency upon payment of the taxes, penalty and interest and costs of advertising.

Certificate of delinquency shall bear interest from the date of issuance until redeemed at the rate of 12 per cent per annum.
