

PROPAGANDA OF JACKSON IS OLD

Single Tax Paper Loud In Opposing Preparedness Program

Sam Jackson, the noted single tax advocate of Portland, owner of the Portland Journal, the only Oregon paper using the Hearst news service, is employing the tactics of William the Second of Germany in an effort to kill off the country press. His propaganda is no more truthful than that of his famous prototype, the Kaiser. His campaign to get rid of the smaller papers is no less ruthless than that of the other kaiser in his efforts to get rid of the smaller nations. His ambition to be the big czar in Oregon newspaperdom is no less vaunting than is the ambition of the kaiser to be the ruler of Europe. The smaller nations in Europe that refused to submit to the kaiser's dictation were made to feel the strong hand of the powerful Hun. The small country newspapers of Oregon that for years have resisted the Portland czar's schemes to put over the single tax and other fads are now feeling the strong hand of the millionaire owner of the Portland Journal. With them out of the way he can proceed to fasten his fad tentacles upon the state with less opposition.

This is the same paper that two years ago was defending the slaughter of innocent women and children on the Lusitania by the reterated statements that people had no business to cross the Atlantic anyway. This is the same paper that insisted in loud headlines and screaming editorial that this was a rich man's war and that it was the munition manufacturers and Wall Street that were trying to drag this country into it, when as everybody knows this war was started by the kaiser. This is the same paper that fought an increase in our army and navy and was against all preparedness and, in short, an advocate of many things opposed to many other things whose support or opposition now would cause it to be called up on the federal carpet—Corvallis Gazette-Times.

AUTOCRACY MUST GO—PRESIDENT DECLARES

WASHINGTON, Oct. 14.—President Wilson has answered Germany's peace proposal with a decision which not only fulfills the expectations of supporters of his diplomacy, but also dispels the fears of those who predicted that he would offset victories at arms with defeats at diplomacy.

No peace with Kaiserism; autocracy must go; no armistice can even be thought of while Germany continues her atrocities on land and sea; one cannot be considered unless it fully is dictated by the allied commanders in the field in such terms as absolutely provide safeguards and guarantees that Germany's part will not be a scrap of paper; this, in a few words, is the President's answer.

If it does not bring a capitulation which may be more than an unconditional surrender, allied diplomats and American officials believe it may cause a revolution in Germany.

beyond question it speaks for the entente as well as the United States. The dispatch of the President's reply was followed by the issue of the following formal statement by Secretary Tumulty:

"The Government will continue to send over 250,000 men with their supplies every month and there will be no relaxation of any kind."

Quite outside of the formal phrases of a diplomatic document, that was President Wilson's word to the world that he had no thought of stopping the fighting at this stage.

The Senate chamber rang with applause as the President's answer was read a few minutes after it had been announced at the State Department.

Senator Lodge, the President's chief critic in his course until today, issued a statement expressing his gratification at the President's decision.
