WASHINGTON, Dec. 2.—President Wilson's annual address was devoted chiefly to discussion of the domestic problems of the nation.

President Wilson told congress that it was international justice that we seek, not domestic safety merely.

GERMANY MUST PAY IN FULL FOR WARDAMAGE

LONDON, Nov. 29.—Germany must pay a war indemnity up to her capacity. Premier Lloyd George announced in an address at Newcastle-on-Tyne today.

"There must be a sternly just peace and never again will Germany be allowed to betray the country that has given them a domicile," declared Premier Lloyd George.

"The principle always has been that the loser must pay. That is the principle we should now proceed upon regarding Germany. She must pay the cost of the war up to her capacity."

"We should so act that men in the future, when they are tempted to follow the example of the German rulers would know what is awaiting them in the end."

Lloyd George continued: "Is nobody to be punished for the crimes of the war? I mean to see that the men who mistreated our prisoners shall be made responsible. But I do not want, when the war is over, to pursue any policy of vengeance."
