POSTOFFICE AND STORE AT JENNINGS LODGE BURNS FRIDAY NIGHT

Among the handsome floral tributes sent were from the employees and officers of the Willamette Valley Southern Railway Company, Order of Railway Express, Portland Railway, Light & Power Company, B. P. O. E., Willamette Rebekah Lodge, Woman's Club, I. O. O. F. Besides many from the other friends.

During the service a quartet sang very impressively, "I Need Thee Every Hour," "Abide With Me" and "Beautiful Isle of Somewhere," favorite selections of Mrs. Miles. The quartet was composed of Mrs. W. C. Green, Mrs. Frank Schoenborn, James Shannon and Joseph Alldredge. Mrs. G. W. H. Miller was the accompanist.

The pallbearers, members of the I. O. O. F. and the B. P. O. E. were J. J. Cook, S. S. Walker, Judge Grant B. Dimick, J. L. Waldron and F. E. Albright.

Following the services in which the Willamette Rebekah Lodge also assisted, the remains were conveyed to the Portland crematorium, where they were incinerated at the request of Mrs. Miles, shortly before her death. Many friends attended the last sad rites at the crematorium, making the trip by automobiles.

Mrs. Sarah Elizabeth Miles was born near Davenport, Ia., November 19, 1854, and accompanied her parents, the late Thomas and Emily Johnson to the Western Coast, arriving here in 1872, where the family settled in Portland, remaining there until the spring of 1874 when they moved to Seaside, Oregon, where the father purchased a farm and the place still bears his name as the Johnson place, and Johnson's Crossing near the farm is also named for the pioneer.

In March 1876 Sarah Elizabeth Johnson was married to F. A. Miles at Seaside, Oregon, and remaining there until 1879 took up their residence at Highland. In the spring of 1881 left for Missouri, where they made their home at La. Plato, until 1889, when they returned to Oregon, taking up their residence in Oregon City, where they have since resided, and where many friends have been made.
