Lieutenant Willis Killed at Spokane

CANBY, Or., Jan. 22.—Lieutenant W. S. Willis, of Spokane, husband of Mrs. Cora Willis, the latter formerly of this city, died from injuries received by falling through a pole hole opening in the dormitory floor of apartment No. 5 of the city hall fire station at Spokane, Sunday morning, January 9. He was the son-in-law of J. J. Sandness, and was one of the most popular men of the fire department. His funeral was one of the largest ever held in Spokane, being attended by the Elks' Lodge, of which he has been an active member, by the fire department, and hundreds of friends.

The funeral services were held from a chapel the following Wednesday afternoon, with Rev. S. L. Devine, pastor of the Presbyterian church, officiating, and the interment was in the Elks' Rest of Greenwood cemetery, Spokane. The pallbearers, members of the fire department, were in uniform. The floral tributes were in large numbers.

Lieutenant Willis joined the fire department of Spokane on December 31, 1909, entering as a truckman, and was promoted to lieutenant December 18, 1918. During his service as a fireman he assisted in saving the life of a woman and several firemen, who had been cut off by the flames. Many other heroic deeds had been performed by the young fireman. It was during the Murgatroyd fire that he was badly gassed.

The accident causing Lieutenant Willis' death occurred Sunday morning at 12:30 o'clock as he was returning to his room from a lavatory, and it is believed that he stumbled and pitched forward into the hole, striking his head on the concrete floor. He was found by Thomas O'Rourke, a night operator at the alarm switch board, who heard Willis' body strike the floor, and immediately rushed to his assistance. The young man never regained consciousness, and died two minutes later in the emergency hospital.

Three years ago Mr. Willis married Miss Cora Sandness, of this city, who survives him, and also a sister in the East.

J. R. Vinyard Store Entered Saturday

CANBY, Or., Jan. 22.—During Saturday night the general merchandise store of J. R. Vinyard was entered through a rear window, and shoes valued at about \$150 were stolen. It is probable that other goods were also stolen at the same time, for the interior had the appearance of the robbers' visit. Among the other goods that are missing are two suit cases. Several months ago the Carlton & Rosenkrans store was entered by two men, but through the efforts of one of the employees, who remains at the store at night, several shots were fired at the would-be-robbers, and they made their escape, after gathering a lot of goods that were ready to carry them away. They escaped empty handed, for clothing was left on the floor and their reception was warmer than they had anticipated when visiting the store.

Albert L. Snell Goes to Reward

CANBY, Or., Jan. 22.—Albert LeRoy Snell, one of the prominent and highly esteemed residents, died suddenly at the family home from neuralgia of the heart Saturday night. Mr. Snell came to Oregon from Iowa in 1875, and for some time resided in Portland, later taking up his residence at Canby, where he has since resided, and where he had made many friends. Mr. Snell was 71 years of age, and enjoyed good health until a few days before his death. Mr. Snell is survived by his wife, Mrs. Buena Vista Snell, of Canby; four daughters, Mrs. Inez Thomas, of Portland; Miss Florence Snell, Mrs. Josephine Fletcher and Mrs. Buena Mitts, of Canby; a son, Ross, of Canby. He also leaves two brothers, Grover Snell, of Cedar Falls, Wash., and Edward Snell, of Drain, Oregon. The funeral services were held on Tuesday afternoon at 2:30 o'clock from the Methodist church, with Rev. George Speas, pastor, officiating. Many friends of the family attended the services and the pallbearers were old time friends of the deceased. The floral tributes were beautiful, many of which were sent from Portland.

CANBY, Jan. 22.—J. J. Sandness, real estate dealer, has made a number of important sales during the week. The price was considered remarkably low, only \$1800. The property consists of a dwelling, modern, and a large lot, 100x115 feet. Mr. Sandness has also sold the A. W. Brennet place of 40 acres, located about four miles from Canby and on the Mullno road. The purchaser is Dave Westburg, who recently sold his property east of Needy. Mr. Westburg will take possession about January 25. The price for the property was \$6000 cash.

Stolen Car Is Found at Canby

CANBY, Or., Jan. 22.—Through a little detective work on the part of Aaron White and Grant White, of this city, a stolen car was returned to its owner through Sheriff Wilson Saturday.

White, who is employed on the construction work of the highway was on his way to work when he saw four boys alight from a big Hudson-Six car, and leave the machine near the side of the road. When reaching Canby he told White of what he had seen, and the latter immediately notified Sheriff Wilson at Oregon City. Mr. Wilson arrived shortly and further investigation found the stolen automobile was owned by Mr. Jones of Portland. No further clue is had of the boys having stolen the car, for they made their escape soon after leaving it beside the road.

CANBY, Jan. 22.—Frank Kraxberger, the well known resident of the Maeksburg district, has just closed the deal for the purchase of the old Casto place of 80 acres in the New Era district, from L. S. Casto, administrator. The purchase price was not made known. Mr. Kraxberger bought the place for his son, Emil J. Kraxberger, who has been living in Portland for the past four or five years, but desires to return to farm life. It will be used for general farming purposes and for the raising of prunes, there being a splendid orchard of prune trees on the place. Mr. Kraxberger Sr. has also just purchased 80 acres from his brother, Otto Kraxberger, which is one-half of the Henry Kraus estate, for which he paid \$18,000. The one-half he sold to his brother brought \$10,000. The property is in the Lone Elder district, about two and one-half miles from Canby. The deal was made by J. J. Sandness of Canby, as was the original deal.

Profit in Gooseberries

Salemites, or rather those who have acreage in that favored section, are turning to the gooseberry as a standard crop, and one that according to the figures submitted offers a profit, that should tempt those with the land to plant a large acreage.

It is claimed that the soil and climate conditions are exceedingly favorable for gooseberry culture in the Willamette Valley. W. Frank Crawford, a fruit grower in Polk county within eight miles of Salem, reports to the Salem Statesman the results from one acre, that has given him an average crop of 9,000 pounds yearly, with the yield running one year as high as 16,000 pounds. Gooseberries on the public market in Portland last year sold as high as 25 cents per pound and at no time were cheaper than three pounds for 25 cents. With a cannery taking the surplus a profit making price would be assured. The country around Oregon City is fully equal to the Salem section for berry culture. May it not be a hope not beyond the possibilities of realization that within a few years the Willamette Valley within the trade radius of Oregon City, may rival the Puyallup Valley as a berry growing center.

PORTLAND YOUNG MEN LAND IN PENITENTIARY FOR THEFT OF WHEAT

J. Holland, Frank Ruffe, and D. E. Boone, Portland youths who entered pleas of guilty to stealing nearly fifty bushels of wheat from the granary of George H. Brown of New Era, were sentenced Wednesday afternoon by Judge J. U. Campbell to serve from one to ten years in the penitentiary at Salem.

Boone and Ruffe were employed in the ship yards during the war and drew high wages, Boone during a portion of the time earning as high as \$125 per week. Laid off in November the high price guaranteed by the government for wheat was irresistible and proved their undoing. They were apprehended when their automobile load on 82nd street near the Multnomah line by Deputy Sheriff J. E. Meads. Two hours after receiving their sentences they were taken to Salem by Sheriff W. J. Wilson and Deputy H. H. Hughes.

ORLO G. DE SHIELDS DIED WEDNESDAY AT HIS MOTHERS HOME

Orlo G. De Shields, a well known young man of Clackamas Station, died at the family home Wednesday afternoon.

Mr. De Shields was born July 17, 1873, at Clackamas Station, where he has since made his home. He is the son of Mrs. Anna De Shields and of the late Pleasant De Shields, who died at Clackamas about a year ago. The remains are at the funeral parlors of Holman & Pace in this city, and the funeral services will be held at the Damascus cemetery on Friday morning at 11 o'clock.

COUNTY REGULATES HEAVY TRUCKS ON CLACKAMAS ROADS

Heavy trucking will be regulated in Clackamas county, under orders from the county court to Deputy Sheriff Meads, who has been active this week in restricting truck hauling over the roads in a number of sections of the county. The recent heavy frosts have made some of the highways peculiarly susceptible to injury, and as a result the road from Cottrell to Sandy and the Mt. Hood road east of Sandy have been closed to heavy trucks until February 5. Similar restrictions will be placed on other roads, unless truck operators and drivers voluntarily agree to treat them with respect.

CAMPAIGN TO STOP TRUCK OVERLOADING HAS BEEN STARTED

The campaign to prevent trucks overloading is on in earnest. The first offender, the Independent Auto Truck Co., operating from Portland to upper Willamette river points, was apprehended by Deputy Sheriff H. E. Meads and taken before Justice Livy Stipp, charged with loading six tons on a truck of four tons capacity. A fine of \$10 was assessed.

WANT POSSESSION OF FARM

Last February W. F. Young of Sherwood leased 160 acres with stock and implements to Gust Agardes for a specified term with a sale clause, which was made a part of the lease. In September Mr. Young sold the property to Fred H. Strong, contracting to give possession in October. Possession has been refused according to the complaint filed with the clerk of court, and an action brought to restrain Agardes from disposing of any of the stock and requiring him to deliver the premises to the purchaser.

MORRIS IS HEAD OF COMMERCIAL CLUB THIS YEAR

Dr. L. A. Morris, for several years an active member of the Commercial Club and chairman of the Good Roads committee of that organization, was Wednesday night elected president at the annual meeting, succeeding M. D. Latourette, who has served two successive terms. Other officers chosen were Raymond P. Caulfield, vice-president; O. D. Eby, treasurer, and E. E. Brodie secretary. The new board of governors is composed of R. L. Holman, J. J. Cooke, T. Osmund, M. D. Latourette, A. E. Rugg, Raymond P. Caulfield, E. E. Brodie, L. A. Morris and O. D. Eby, the last three of whom were elected at the annual meeting Wednesday night for three year terms. President Morris has promised an active year for the club, which is in good financial condition, out of debt, with a comfortable balance in its treasury.

RICHARD MARION LONG WELL KNOWN PIONEER PASSES TO HIS REWARD

Richard Marion Long, one of the well known residents of Canemah, and who was favorably known throughout Clackamas county, being the son of early Oregon pioneers, died at the Oregon City hospital on Tuesday night after a 15 weeks' illness. The remains are at the funeral parlors of Holman & Pace, and the funeral services will be held from the parlors on Friday afternoon at 2 o'clock, with Rev. C. H. L. Chandler, rector of St. Paul's Episcopal church, officiating. The interment will be in the family lot in the Canemah cemetery, and the remains will be laid to rest beside those of his wife, the late Mrs. Elizabeth Hedges Long, who died twelve years ago.

Richard Marion Long was born on November 2, 1857, where is now located West Linn, and has resided most of his life at Canemah.

Mr. Long is survived by two daughters, Mrs. W. B. Howell, of this city; Mrs. Rae Cole, of Portland; three sons, Gilbert, Elton and Arch Long, of Oregon City. He also leaves two grandchildren, Wallace Cole, Jr., of Portland, and Betty Jane Howell, of this city. Mr. Long was a cousin of G. C. Shields, of Portland; E. L. Shaw and Mrs. C. D. Latourette of this city, and a brother-in-law of J. E. Hedges and Gilbert L. Hedges, of this city. A sister resides in California, and two brothers, Joseph and Charles Long, of St. Johns, Wash.

FURNITURE CONCERN TO PUT UP NEW STRUCTURE

Announcements involving the improvement of the Bank of Commerce property on Seventh and Main streets, the erection of a modern banking house on the corner, the leasing of the property now occupied by a pool hall to Busch & Sons for a furniture store, and the lease of the present Busch store to the Clackamas County Auto & Tractor Co., were made public Wednesday.

The bank purchased the holdings of the Frank Jaggar estate on the principal corner of Oregon City last year for a price in the neighborhood of \$50,000, with the primary object of securing a desirable site for the banking institution, which, according to present plans, will be constructed this year. Details are yet to be completed, but it is proposed to erect a structure with a frontage of about 40 feet on Main street, running to the depth of the property on Seventh street. The banking house will be two stories in height, the architectural features will be strictly in keeping with the appearance of a modern financial building, and the second floor will be leased to professional people whose names have not been made public.

The ground now occupied by a frame building used as a pool hall is to be leased to Busch & Sons, who will erect, within a few months a two story building of brick and stucco, with a full basement, which, in connection with the present store in the city hall building, will be used as a retail store, replacing the firm's main store on Eleventh and Main streets.

The Clackamas County Auto & Tractor Co. will occupy the present Busch Furniture Store on Eleventh and Main, taking over the first and mezzanine floors and basement, and the upper floors of the building will be held by the Busch furniture firm for storage purposes.

It is also announced that Frank Busch, pioneer furniture dealer, will retire from active connection with the business, which will be directed by his sons, Edward J. and John H. Busch, and that he will devote his attention to the business of manufacturing at his plant in Oreg. City. The new Busch building will be erected this spring, and it is expected construction will commence about April 1 and be finished within six weeks. No decision has been reached as to the occupancy of the site between the new bank building and the Busch store, but it is considered likely that a ground lease for some suitable business will be negotiated.
