We're Glad of It

The announcement that the ownership of the Hawley Pulp & Paper Co. is not to pass into alien hands is welcome news to Oregon City people. While it was understood that the Hearst interests would acquire control of the concern and that W. P. Hawley would remain here as manager, the time would probably have come, sooner or later, when local interests would cease to have much to do with the operation of the plant.

The personal equation in the conduct of a big business is worth something to a town. Non-resident owners can hardly be expected to have the same first-hand interest in the welfare of a community as the men who come into daily contact with its people. It is possible, of course, to operate a large plant at a maximum capacity and to adjust working conditions from a long distant view, but it is vastly more comforting to be able to approach in a personal way the men who have their money invested.

Mr. Hawley has in many ways evidenced a concern for Oregon City's future. The town has done well by him and he apparently wants to do well by the town. The erection, at his expense, of a handsome memorial for the establishment of the first newspaper in the west has been the means of giving to Oregon City almost unlimited publicity throughout the United States. Along with A. R. Jacobs, president of the Oregon City woolen mills, Mr. Hawley was ready to assist in the solution of Oregon City's housing problem. We are glad, therefore, that the big mill has not been sold and hope it will continue for many years to remain in the hands of the Hawleys and their associates, who have a direct interest in our city.
