The school closed on Friday morning of last week, there being over 12 students failing to attend. It was then decided to open school Monday, but there were many other cases when Monday morning arrived, and it was deemed advisable to have the schools close at least during the present week.

Only children were first afflicted, but now it seems that the older ones have come down with the disease. None of the cases are serious.

It was necessary to postpone the opera that was scheduled for last Saturday evening, which will be presented at a later date.

ENGLISH MONEY DROPS RAPIDLY IMPORTS CEASE

NEW YORK, Feb. 4.—The greatest single drop demand sterling has taken since the present decline in foreign exchange began, was made today when the British pound opened at \$3.27 1/4, off 5 1/4 cents from yesterday's close.

Bankers predicted that the bottom had not yet been reached in the slump of foreign moneys in exchange for American dollars, and further declines today were expected.

In the first half hour sterling fell to \$3.26 3/4.

Franc checks were 14.82 francs per dollar, off 30 centimes, and Mrs. 18.02 per dollar, off 53 centimes.

The German mark fell to a new low record at \$0.0103.

LONDON, Feb. 4.—The importation of cotton was stopped today, because of the unprecedented fall in the exchange rates on the English pound. Some cotton shipments were turned back.

The stoppage of imports is the first telling effect of the exchange rate reaching a point where it does not pay traders to import goods, said the Star.

WILLIAM H CARPENTER PASSES AT GLADSTONE AFTER LONG ILLNESS

William H. Carpenter, of Gladstone, died at the family home early Monday morning from complications arising from influenza a year ago. His health has been gradually failing since that time.

Mr. Carpenter was born at Waupun, Wisconsin, 58 years ago, and came to Gladstone from St. Joseph, Mo., last year.

He is survived by his widow, of Gladstone, and the following children: D. D. Carpenter, of Missoula, Montana; Cyril Carpenter, of St. Joseph, Mo.; Chester Carpenter and Gladys Carpenter, of Gladstone; Miss Lena Carpenter, who is employed in Portland; William Carpenter, who is attending school in Portland; and Miss Helen Carpenter and Roy Carpenter, of Gladstone, the former a student of the Oregon City high school. Mr. Carpenter was an uncle of Mrs. T. E. Gault, of Gladstone.

Putting Us Wise

After reading the salutary statement of Edwin T. Meredith, who has just become a member of the cabinet as Secretary of Agriculture, we are just as wise as we were before. Mr. Meredith has been a publisher of a farm journal, and a successful one. He was a director in two banks, and he is regarded as a man of affairs. We assume that he felt it was expected of him that he make a formal declaration upon taking over his new duties, and he therefore issued a formal statement of the causes of the high costs of living and then proceeded to hazard remedies.

Mr. Meredith says that elimination of useless employees in non-productive business, the speeding up of all lines of industry commensurate with the present activity of the farmers, and determination of retailers and jobbers to exact only a reasonable profit will prove a solution for the high cost of living problem, which cannot be solved through the efforts of one class.

The new secretary very naturally takes the angle of the farmer in formulating his opinions. Speaking for them, he says they are willing to assume their part of the responsibilities as American citizens, but they ask that those engaged in distribution eliminate the lost motion and not put so great a burden upon production as there is today.

Of course, the farmers have had little to do with making living costs high. Prices are not usually regulated by the producer. During the war, the government itself put a price upon raw products, and while that price was high, compared with what had been charged before, the farmers are complaining today that the guaranteed selling price of wheat, for illustration, is not sufficient to give to the grower the profit to which he is rightfully entitled.

Such things as the permanent recognition of the eight-hour day would have a tendency to at least stabilize prices, but this is a feature that Mr. Meredith does not appear to recognize. Neither does he refer to the excess profits tax as a contributing factor of the cost of living. It is evident that the secretary places the blame for high prices on the middleman. The question of proper and efficient marketing is a vexing one, and if the new cabinet officer can devise a workable plan to deliver the farm products to the consumer in a more direct channel, he has our best wishes. If, however, the profit made by the duplication, so-called, in distribution methods, is diverted to the grower or is divided between the farmer and the distributor in larger shares, then the problem of high living costs will not have been solved at all.

Tough Luck For Sure Holidays Fall Sunday How About Leap Year

Those who are employed and who have always looked forward with pleasure to having a "day off" on a holiday will be disappointed during 1920, for these are a number of holidays falling on Sunday. These are Washington's Birthday, February 22; Decoration Day, May 30; Independence Day, July 4; but Christmas comes on Saturday and thus leaves two holidays after all—Saturday and Sunday.

Farmers Week At Gresham Feb. 9th

A farmers' week for Multnomah county will be held at Gresham beginning February 9. The study of dairying, farm crops, soils, fertilizers, horticulture and poultry will be taken up. Dairying will receive attention February 9 and 10, farm crops 11, soils and fertilizers 10 and 11, poultry and a general program 12, and horticulture 13. Lectures and practical demonstrations will be included in the work.

Professors E. B. Fitts and E. L. Westover will be instructors in the dairy work, Professor C. V. Ruzek in soils and fertilizers, Professor A. G. Hyslop in farm crops, Professor A. G. Lunn in poultry and Professor W. S. Brown in horticulture.

MOTORISTS ARE PINCHED BY OAK GROVE OFFICERS

Peace officers of the Oak Grove district have been unusually active of late and have, within the last few days, arrested nine motorists for alleged violations of the state traffic laws. Three of them, H. F. Tachigai, Ralph C. Parker and Frank Bradley, are residents of Oregon City. Two officers double up to catch the unwary motorists. The pair are stationed some distance apart and one flashes a signal to the other with a pocket torch. Such minor violations as the absence of a tail light are sufficient to cause an arrest. CITY SETS WHEELS IN MOTION TO BUILD HALL

Declining to rent any of the city property for any purpose, and emphasizing the policy that the property is for sale, the city council Wednesday night started the ball rolling for the actual sale of lots and blocks held by the municipality, and arranged a conference for tonight between the special council committee and the water board for the purpose of making definite plans for financing the construction of a city hall and fire station and for the purchase of modern fire apparatus and the maintenance of a paid fire department. The application of Mrs. Rosenthal to rent certain city blocks for garden purposes was denied.

Oregon City has considerable property in various sections of the city, having acquired it through failure of the original owners to pay for municipal improvements. J. C. Spagle, secretary of the American Legion, told the council that the Legion was back of the proposal to build a new city hall and desired to cooperate to that end.

Vigorous protests against the consideration of McLaughlin Park as a site for a new city hall and fire station were voiced by the Daughters of the American Revolution and the Derthick Club.

Councilman Kelly deplored the fact that the municipal elevator had not resumed operations and said it was high time that something was done to relieve the situation. The matter was referred to the street committee.

A petition for the improvement of Ninth street from Taylor to Pierce street was referred for investigation to the committee on streets.

The city recorder was requested to make more rigid the enforcement of the traffic ordinance. Mr. Kelly urged that official to fine violators to the limit, having in mind the depleted condition of the city's finances.

The street committee was authorized to purchase a Ford car for the use of the street department, on monthly payments of \$50, and permission was granted City Health Officer Norris to use the police record in making his official visits.

TAX DEPARTMENT IS READY FOR BUSINESS GOOD OPENING DAY

Wednesday was the first day's collection of taxes for 1919 in the office of Chief Deputy Tax Collector I. D. Taylor, and his efficient corps of helpers, including Miss Jessie Padcock, Miss Mary Confer and Miss Eloise Alldredge, were busily engaged in taking in the money from the property holders. Although this was the first day, which is considered a dull day in tax collection, the amount paid in was \$1,797.33.

The taxes for 1919 will be higher except to those people residing in District no. 1, north of the Clackamas river, who did not vote a special road levy. Others will pay a ten mill road tax.

The highest tax paid by any individual was \$253.10. The lowest was \$2 cents.
