

PLAINTIFF ACCUSED OF MISCONDUCT AT BEACH

Witness Testifies That Mrs. Hawley and Life-guard Were Very Friendly; Out Late At Night; Baby Was Neglected and Found Asleep in Bathroom; Defense Asks Decree.

The defense in the Hawley divorce case filed a supplemental counter claim or cross complaint when court opened Tuesday morning, charging Marjorie Hawley with cruel and inhuman treatment because of her charges and supporting testimony to the effect that Willard was guilty of actions of a criminal character. It is stated in the cross complaint that the charges were made in the presence of a great crowd of friends and acquaintances of both parties, that they were false and malicious and were made by the plaintiff with the intention to degrade Willard in the estimation of the public and to entirely destroy his reputation. Upon the allegations of the cross complaint the defense has asked for a decree, for the care and custody of the baby and divesting the plaintiff of all interest in the real and personal property of the defendant.

The plaintiff filed an answer under stipulation Tuesday afternoon, denying every allegation in the cross complaint.

When W. P. Hawley, Sr., resumed his testimony under cross-examination Tuesday, he was asked by C. D. Latourrette if he had done all he honorably could to bring about a reconciliation of the young people before the papers were filed.

"Yes," replied Mr. Hawley. "I did not use money, as I saw that was what was wanted. After the original complaint was filed I told my attorneys I was willing to settle the case in a proper manner, and if the divorce should be given to Willard, I would oblige myself to pay Marjorie \$150 a month as long as she should remain single, and that I would create a trust fund of \$100,000 for the baby and Mrs. Hawley and I would take the child and adopt her."

"The term fifty-fifty would not necessarily mean half of Willard's property or money, would it?"

"It would split very nearly in the center, I think," was the reply.

"Marjorie never had money enough to buy lawyers and detectives, did she?" queried Latourrette.

"I do not think any of us have money enough to buy lawyers," said Mr. Hawley, and the spectators tittered. "If I should go down to your bank tomorrow morning, Mr. Latourrette, and say that I wanted you to go fifty-fifty with me, what would you think?"

"Well then I will ask you this question. Suppose Willard had said to her, Angel Wings or Angel Doll or whatever he called her, here is a deed to this house or here is \$1000 in bonds do you think she would have been satisfied?"

"No, on account of her attitude, I don't think she would."

Mr. Hawley said on redirect examination that Marjorie had been his son's wife and the mother of his child and he did not want to see her turned out into the world without comfort, even after she had made awful charges against Willard.

"How do the clothes Marjorie is wearing in court compare with those she has?" asked Latourrette.

"It's a joke," declared the witness. "There is no comparison at all. I have seen her wearing silk dresses and play around the floor with the dog and the dog would tear the silk dress and I believe she is wearing this dress for the effect she thinks it will have on the case."

For the first time since the case started, Marjorie shed tears upon reference to her clothes.

Mr. Hawley said that after the amended complaint was filed that he wanted his son to come into court and clear his name of the charges that Mr. Schuebel was telling up and down the street, he said.

"This little girl," said Mr. Latourrette, referring to the plaintiff, "was to be turned out in the snow."

"No. You know better than that, Mr. Latourrette. You were present at the negotiations for a settlement."

"Were you considerably wrought up over this case?"

"Wouldn't you, Mr. Latourrette, if it were your son?" returned the witness.

"I guess you're right," said Latourrette. "I suppose I would."

The comings and goings of Marjorie Hawley, a plaintiff in the divorce case

home, said that Willard was good to his wife.

"Mrs. Hawley changed her clothes four or five times a day," said the witness, "and every time I would go into the room, they would be laying on the floor. Mrs. Hawley had a bell at the head of her bed and every morning she would have me open the door for the dog and cat and they would get in bed with her. One day she asked me to go to Larson's store after some bananas, and I came back and went in the house through the front door, instead of through the back door. She told me that slaves were supposed to come in the back way and I quit. She always refused to speak to me on the street, though Mr. Hawley always did, and every morning I had to clean up the kitchen after the dog and cat had slept in the room."

"You do not feel kindly toward Mrs. Hawley," observed Mr. Schuebel.

"I do not see how I could, after the way she treated me," returned the witness, who said her mistress wrote her a 16-page letter and left it on the table, giving her instructions about what to do around the house. Mrs. Nona Ferguson who was the first domestic the Hawleys had after they moved into the little house on Main street, said that Mrs. Hawley would always find fault with everything.

"I was treated very nice by Mr. Hawley," said the witness, "but Mrs. Hawley did not treat me well at all. She laid in bed until 11 o'clock most every morning and would sometimes have breakfast in bed. She left her clothes on the floor and I would have to pick them up."

"Do you like Mrs. Hawley personally?" questioned Schuebel.

"I should say I don't," was the answer.

Mr. Schuebel attempted to read to Ida McConnell a letter from Willard to his wife, in which he wrote: "I am glad you let Ida go. You did just right. She was no good and too slop py anyway." The letter had already been introduced in evidence and the court held the testimony was not competent under cross examination.

Mrs. Fred Gadke, who made all of Marjorie's clothes except those she bought in the stores, said she had four dresses for the plaintiff when the suit was filed.

"One had been there so long, she had forgotten about it," said Mrs. Gadke. "There was never a time she did not have one or two silk dresses being made."

Mrs. W. S. Bennett said she had been to the Hawley house frequently, and that Willard's attitude had been so affectionate toward his wife that the witness had remarked about it. She had noticed that Marjorie had neglected her baby.

"She said she would like to see Willard get drunk and smoke and chew and then she would call him a man," said Mrs. Bennett.

Judge Bagley Tuesday afternoon overruled another motion of the defense to dismiss the case, the same cause being presented as formerly that Marjorie had charged the defendant with degeneracy and that a divorce could not be granted on the testimony of an accomplice.

"Before I would see the Hawleys get my baby I would say she wasn't Willard's," said Mrs. Marjorie Hawley to Mrs. Ralph Eddy, according to the testimony of the latter Wednesday morning. Mrs. Hawley had testified on direct examination that Mrs. Eddy had taken this position in a hypothetical case, and that she had agreed with Mrs. Eddy, who was placed on the stand to impeach the plaintiff's testimony. Christian Schuebel, counsel for Mrs. Hawley, objected to the question propounded by Harrison Allen on the ground that it was leading, and Allen, who was not adverse to having a little fun out of the case when opportunity offers, observed:

"Counsel has forgotten what I taught him when I was district attorney here and he was my deputy."

Marjorie was called back to the witness chair Wednesday morning to identify some kodak pictures that were taken at Bar View. One of the photographs was of Claud Johnson, a coast guard who was with her much of the time at the resort. Johnson was wearing Mrs. Hawley's wrist watch in the photograph, and she admitted he had worn it two days and had returned it at a dance.

"I brought the films home," she said and Willard seemed to have slipped them out of the house. He has seen them time and again."

"What did Willard say to you about sending these pictures back to Bar View to the boys?" she was asked.

"I do not remember any such conversation," replied Mrs. Hawley. "But it might have occurred." Mrs. Hawley said when Willard was at the beach with her, he had taken about two dozen pictures.

"I don't notice that any of the two dozen pictures taken when Willard was there have Claud Johnson in them," said Mr. Allen. "You made no bones about giving your picture taken with Johnson?"

"My goodness alive," exclaimed Mrs. Hawley, "don't people at the beach have their pictures taken with lots of people they never saw before?"

The witness testified that she had written to Willard about John Brown, aged 18 years, with whom she had walked down the beach on her way home, and upon receipt of her letter Willard had called her on long distance telephone and said:

"What do you mean by running around with that man over there?"

When she returned home she explained to Willard that Brown was only a boy, and Willard replied:

"Oh, then he isn't a great big man like I am."

Mrs. R. W. Kirk concluded her testimony Wednesday morning. She had seen Johnson and Marjorie at the train when the latter was leaving for home. On cross examination she explained she was able to fix the dates of occurrences by the fact that the Kirk guinea pig had been killed by Mandeville Robinson's dog. Her little girls had placed the dead pig in a box and consigned it to a watery grave in the bay, but the pig and its coffin became separated and the animal

blasted away. Attorney for the plaintiff attempted to show that while the country was at war that it was not unusual for women to go out of their way to be nice to men in the uniform of the United States.

"I do not understand," said Mr. Allen, "that it is the duty of all the life guards to love all the married women at the beach. It would not even be proper for Charley Latourrette to do it under the circumstances."

Mrs. Mabel Morton, of Portland, who occupied a cottage adjoining that of the Hawleys, said that the plaintiff dressed conspicuously and that she recognized Mandeville Robinson's voice at the Hawley house about midnight. She came home one night about eleven o'clock and found Winnifred Ball crying on the porch of the Hawley cottage, and the little girl said the maid had left her alone in the house. She said the maid came in about 20 minutes later.

Mrs. Willard P. Hawley, Jr., plaintiff in the Hawley divorce case, concealed for a half hour in her bedroom an unknown man, while her husband was in an adjoining room, according to the testimony of Mrs. Leslie Kidder, of Vancouver, Wash., Wednesday afternoon. Mrs. Kidder, before her marriage, was Lena Beckman, and she was a domestic at the Hawley home just after the return of Mrs. Hawley and her baby from Bar View. She started to work on August 20, 1918.

"One evening between eight and nine," said Mrs. Kidder, "while Mrs. Hawley, the baby and myself were in the house, a man called. I was in the bedroom with Mrs. Hawley and the baby was in another room, and Mrs. Hawley told me to get the baby and take her to the bedroom and she went to the door. I could see the man, who had a light complexion and was about the same height as Mr. Hawley. They went into the parlor and sat down on the couch, and she leaned back against his arm, which was thrown over the back of the couch. I was working between the dining room and kitchen and could see them, and Mrs. Hawley looked across and pulled the door shut. She also pulled down the shades. The man was there a half hour when Mr. Hawley arrived in the machine and stopped in the alley. I noticed the man go into Mrs. Hawley's bedroom, and Mrs. Hawley met her husband in the dining room, as he entered through the back door. Mr. Hawley remained in the dining room about 10 minutes and then left, when Mrs. Hawley went back to the parlor and the man came out of the bedroom and stayed about a half hour. After he had gone Mrs. Hawley told me her husband would not return for two hours. The door leading from the dining room to the bedroom was closed while Mr. Hawley was in the house."

"Who discharged you?" demanded Mr. Schuebel.

"Mr. Hawley discharged me," replied the witness.

"Why?"

"Mrs. Hawley had accused me of stealing Mr. Hawley's socks and that didn't set very good."

Willard Hawley was re-called to the stand and said that he had discharged the girl when his wife told him the maid had been stealing. He said he objected to his wife running around Bar View with other men and had telephoned her about it, and that when she returned she had expressed a wish to send some kodak pictures to some of the coast guardsmen at Bar View and he had objected to that.

Mrs. Gilbert Horton, of Portland, testified that Mrs. Hawley's conduct at Bar View was unbecoming to a wife and mother. She said she saw Claud Johnson wearing Mrs. Hawley's wrist watch.

"How did you know it was Mrs. Hawley's?" she was asked.

"I happened to ask him," she said. Mrs. Horton testified to seeing Johnson with Marjorie on the jetty, and said that Mrs. Hawley and Johnson and Mrs. Ball and Robinson paired off.

H. I. Sheldon, a jitney driver living at Garabaldi, met Mrs. Hawley at a dance hall in Bar View. He said her reputation around Bar View was bad. He had seen Johnson and Marjorie lying on the sand in their bathing suits and embracing, and he had seen the two women and two men walking arm and arm.

Miss Ina Davidson, of Tillamook, testified that she stayed at the Hawley cottage the evening of the bonfire, that Johnson and Marjorie came back to the house about midnight, and that she had seen Mrs. Hawley sitting on the bed, with Johnson lying full length on the bed with his head in Mrs. Hawley's lap. A. G. Davidson, who operates a lunch room and confectionery at Tillamook, said that Mrs. Hawley's conduct at Bar View was indiscreet.

M. B. Cooper, a former coastguard who was attached to the Bar View station in the summer of 1918, said he had deep religious convictions about dancing. He is a Seventh Day Adventist.

"I consider a woman who dances questionable," said Cooper. "I base this belief on observations at the beach." The witness said he saw Marjorie and Johnson at the lookout station and that on the night of August 8, which was the night of the bonfire, Johnson and Robinson came in to the station to go to bed about 4 o'clock in the morning. He said it was contrary to regulations for women to occupy the station at the lookout and that while there might be nothing wrong about Marjorie having been with Johnson, that people drew unpleasant conclusions.

"You did not see anything very bad, did you?" asked Mr. Latourrette.

"Everyone draws their own conclusions," replied the witness. "I draw mine and you draw yours. I found several young ladies at the beach who didn't dance, continued Cooper, and there were some respectable people there."

"Then if the young girl danced you would look out for her?" asked Latourrette.

"Safety first," was the laconic reply. Mrs. Fred W. Smith, of Los Angeles, a former residence of Meldrum was at Bar View during the summer of 1918.

"Mrs. Hawley's conduct was certainly not very good," she said. "I can't remember seeing her more than once or twice without Johnson. She wore a low neck gown with short

sleeves at the beach dances and was very conspicuous. Johnson carried her baby to the train when she left."

Mrs. M. W. Kelsey testified that a good many people at Bar View thought Marjorie was out of place because of her conduct and her attire. Her daughter, Helen Kelsey, said Marjorie paid special attention to Johnson at the dances. She testified to having seen Marjorie, Mrs. Ball with Johnson and another coast guard in a restaurant at 3:30 A. M., after a dance and she afterwards saw Johnson with Marjorie on the trail coming down from the old lookout station on a Sunday afternoon.

Miss Lena Schroeder, who is at present employed as a domestic for Mrs. Hawley, the plaintiff, said she had formerly worked for the Hawleys in 1916 and 1917, and that Willard had treated her fine.

"Did they ever have any trouble?" asked Harrison Allen.

"Oh just you know—little fusses," she had to wash Mrs. Hawley's little white dog, she said, and would bleach the canine out with bluing water, washing the dog and tying ribbons on it. Willard was also fond of the dog, she said.

Manville Robinson, whose name has been connected with that of Mrs. Ball was a member of the life saving crew at Bar View from April 14, 1917 to September 17, 1919. He entered specific denials to the charges of his intimate relations with Mrs. Ball and said that he and Johnson had been with the girls only twice, once on the night of the bonfire when they had left the house together before midnight and another time when they had walked home together from a dance. He had called at the cottage with some claims but had not gone in. He said that Mrs. Hawley conducted herself in a lady like manner and he had never seen anything of color with her. He flatly denied having remained at the Hawley house until 4 A. M. He was married September 23, 1918 and became separated from his wife six months later.

The defense closed its case Wednesday afternoon and the plaintiff is now introducing rebuttal evidence. The deposition of Mrs. Clifford Ball, who is ill at her home in Portland, will be taken Wednesday night, and the case may be concluded Thursday, with the exception of the argument.
