DISORDERLY CONDUCT OF OREGON CITY MEN CAUSE OF ARREST

CANBY, May 5.—Two young men from Oregon City giving their names as Richard Miles and Carl Walling, but proving to be Auk Smith and Charles Montgomery, caused some excitement in this city Sunday night.

The young men had been drinking too freely, says Night Officer Rothenburg, also deputy sheriff, who placed the men under arrest for disorderly conduct. When the men appeared early in the evening at Canby, and were ordered to "move on" by Mr. Rothenburg. They did so, but soon returned with the automobile going at a zig zag way and the men causing unusual noise, they were immediately placed under arrest at about 1:30.

The arrest occurred near the Southern Pacific depot, and Montgomery, who was sitting in the rear seat of the automobile, immediately showed fight, but the night officer was prepared for this, and after the latter was struck in the head by a heavy blow from Montgomery's fist, Rothenburg, took out his revolver, and ordered him to "cool down."

By this time both men were abusing the officer, who was at that time standing on the running board of Smith and Montgomery's automobile. The night officer was dealt another blow, this time pitching him to the ground, and as he struck the ground his revolver was discharged, narrowly escaping the shot.

As soon as Rothenburg was pitched from the machine Smith and Montgomery started for Oregon City at a rate, Rothenburg says "about 50 miles an hour. As soon as he had recovered his sense, he attempted to procure a tire of the automobile by firing a shot at the speeding automobile, but all shots went wild.

He hastened to a nearby telephone and advised Sheriff W. J. Wilson of the actions of the men from Oregon City, and the sheriff immediately notified Night Officer Ed Surfus, who was watching for the automobile when it appeared in sight, and nabbed both young men, and Monday brought them to Canby where they were turned over to the city recorder, William Knight. Owing to a misunderstanding Mr. Knight thought the men were arrested for speeding, and fined them \$5 and costs, not having been advised of the assault on the night officer.

Rothenburg made a trip to Oregon City Tuesday afternoon, and it is probable that the two young men will have to answer another charge of disorderly conduct.

Deputy Sheriff Rothenburg is still suffering from a lame shoulder caused by being pushed from the automobile. Both men were anxious to have their names withheld from the newspaper, this being told the officers.

CITIZEN'S VOTE FAVORS MODERN FIRE APPARATUS Only one vote was lacking to make unanimous the expression for a triple-combination piece of fire apparatus, consisting of hose, chemical and pumping units, at the meeting of citizens with the committee of seven, held at the courthouse Saturday night.

The discussion preceding the vote was broad and comprehensive, and two representatives of fire apparatus manufacturers were present to talk of their merits of their respective machines.

Direct light was thrown upon the whole question by a letter from the underwriters bureau at Portland to A. A. Price, in which it was stated that the installation of a triple-combination apparatus, with a capacity of 1000 gallons per minute would insure a reduction in fire insurance rates of from five to seven per cent.

Mr. Price further stated that he had been advised that a physical connection with the main running to West Linn would make an added reduction, which might make the total as much as 15 per cent.

The attendance was not large, but there was a good representation of business men and taxpayers, all of whom were interested in the discussion. All of the members of the committee were present, and I. C. Bridger, chairman of the council committee on fire and water, presided.

STRAW VOTE OF WIRES GIVES WOOD MAJORITY The Live Wires of the Oregon City Commercial club in a presidential poll Tuesday gave 13 votes to General Leonard Wood, 12 for Governor Lowden, seven for Hoover, two for Johnson, one for Coolidge, one for Gerard, one for Wilson, and one for McAdoo.

Some wag cast his vote for O. D. Eby, a former president of the club.

The Wires appointed Judge Thomas F. Ryan, A. C. Howland, L. Adams, R. C. Parker and Wallace Caulfield as a committee to arrange for local entertainment for the Shriners while they are in the state, and listened to E. Hoover Young, of the state highway commission, who explained in detail the proposed 4 per cent road bonding amendment. A. A. Price was appointed to initiate a Live Wire campaign for the passage of the local measure authorizing \$15,000 in bonds for the purchase of modern fire apparatus and a 2-mill tax for the maintenance of a paid fire department.

George Quayle, general secretary of the Oregon State Chamber of Commerce, and Mr. Scobey, representing the American City Bureau, which will take charge of a state-wide membership campaign for the Chamber, talked briefly, and A. R. Jacobs was requested to extend an invitation to the Portland Ad club to be the luncheon guests of the Live Wires at an early date.
