

MRS. THOMAS BARKER BRINGS PET HORSE FROM FORMER HOME

Mrs. Thomas Barker, of this city, who resides at Mountain View addition, and whose home was formerly at Brownsville, Oregon, has just returned from that city, after a two weeks' stay with her daughter, Mrs. Lee Putman, and family. Mrs. Barker was a resident of that city for ten years before coming here, and arrived here two years ago to assist in caring for the children of her daughter, Mrs. Frank Shipley, who with her baby, were victims of the influenza.

When leaving Brownsville, Mrs. Barker left her old pet horse, "John" with her son-in-law and daughter, Mr. and Mrs. Putman, and as the horse has attained the age of ten years, and still good for many more years, the owner has longed for her faithful pet, so decided to go after him and bring him here to assist with the garden work. Old "John" seemed to realize that he was to be taken away by his mistress, and when he saw her at the daughter's home, he neighed and whinnied and rubbed his head against Mrs. Barker's arm. When time arrived for the trip to this city, a distance of about 90 miles, he was hitched to the old buggy that has been in the Barker family for many years and the trip made in two and one-half days, stopping over night at Salem.

When other members of the family greeted him here, after completing his long and tiresome journey, the old horse whipped his tail in the air and whinnied and there was great rejoicing in the Barker family for the old pet was back to their home once more. Mrs. Barker says he is to have it easy the remainder of his life.

Mrs. Barker is the mother of Thomas Barker, Jr., who is among the Oregon boys suffering from wounds while engaged in battle in France. He is now receiving medical treatment in the Letterman hospital in San Francisco, he has undergone a number of surgical operations for bone grafting, as he received a gun shot wound in the arm while fighting in the Argonne Forest. This occurred September 29, 1918, and has caused the young man much suffering. He was a member of Company B, 362nd Machine Gun company of the 91st division. He received medical treatment at Camp Lewis from February to July 1919, and then was transferred to the Letterman hospital. Mr. Barker expects to return to Oregon City about July 1.

DECISION DELAYED BY GUESSWORK EVIDENCE IN FISHING CASE

G. G. Gell, who was arrested some time ago by Constable Fortune, was given a trial before Justice Stipp Thursday on charges of fishing within 200 feet of a fishway. After hearing the case Stipp took the case under advisement on account of the nature of the evidence.

Gell was accused of fishing too near the fishway at the river mill dam in the Clackamas near Estacada. On the east side of the river is an island where the mouth of the fishway opens. Gell was fishing on the west side and after the arrest the wardens measured to a point 112 feet below the dam, allowing 12 feet on account of the dam not running straight across the river. They claim that Gell was fishing two feet above the measured point and as the whole matter looked like a guess Justice Stipp refused to make a decision. Gell was not fishing near the fishway but the law says that fishing is not allowed within 200 feet below a fishway.

This case has attracted more than usual interest as hundreds of people have fished there, for years and it has always been considered open to fishing.

James B. Moynagh Funeral Monday

James Bernard Moynagh, youngest son of Mr. and Mrs. Hugh Moynagh, of Twelfth and John Adams street, who died in Salem Friday evening from tuberculosis, and now at the family home here, will be buried in the Catholic cemetery in this city Monday afternoon. The funeral services will be held from the St. John's Catholic church, of which he was a member, Monday afternoon at 3 o'clock. Rev. Hillebrand, pastor, will officiate. The remains will be laid to rest beside those of his brothers, one of whom was Frank Moynagh, who died from injuries received in Montana December 31 when he fell from a hay mow.

James Bernard Moynagh was born at Keystone, S. D., June 28, 1896, and moved with his parents to Camas Prairie, Idaho, coming to Oregon City four years ago, where he was employed in both Hawley and Crown Willamette paper companies until his health failed, and was taken to Salem for medical treatment, and his health has gradually failed. The mother had visited him Tuesday at the tubercular sanitarium, and the young man was looking forward to the time when he would be able to return to his home in this city. His death was sudden, and the parents received word Friday evening that he had suddenly passed away.

A sister, Mrs. George Ruestmeyer, and children, are on their way to Oregon City from Cottonwood, Idaho, to attend the funeral services, and another sister, Mrs. J. C. Robbins, of Carter, Montana, is critically ill, has not been advised of the death of her brother.

James Bernard Moynagh was the fourth son of Mr. and Mrs. Moynagh to have passed away, only two daughters now remaining.

COOS COUNTY MAY BE COMPELLED TO REFUND PART TAXES

MARSHFIELD, May 19.—Coos county may be compelled to pay back \$500,000 in taxes, according to L. A. Liljeqvist, attorney of Portland, who was formerly district attorney of Coos county and who is here to confer with the county officials.

The supreme court has rendered a decision in the case of the Nehalem Lumber company which was appealed. The higher court held that \$250 an acre was the minimum valuation on which taxation could be made on the O. & C. lands, and the Coos Bay wagon road company. The lands in Coos county were assessed the same as private holdings, according to the value of the land or the timber.

DANIELS REPLIES TO CRITICISMS ON WAY NAVY WAS CONDUCTED

WASHINGTON, May 20.—Secretary Daniels today replied to the criticisms of naval officers that he did not take adequate steps to secure sufficient personnel for the navy before the United States entered the war. He told the senate committee investigating the navy's conduct of the war that efforts to link his personnel policies in 1914 with the world war had been "abortive" and declared that if he erred then it was because he followed the precedents established by those who preceded him in office.

REVENUE LAWS MAY CAUSE PRESIDENT TO ASK SUMMER SESSION

WASHINGTON, May 20.—President Wilson will endeavor to keep congress in session during the summer to revise the revenue laws and to provide for the serious financial situation that is confronting the treasury, according to persistent reports among Democratic members today.

Several saw an indication of this intention in the letter of Secretary Houston to the ways and means committee opposing the soldier bonus, stating that some additional taxes may have to be imposed to meet regular requirements of the government.

PRESIDENT IS ASKED TO CALL MEETING OF NATIONS LEAGUE

LONDON, May 19.—The League of Nations council, in session at Rome, has asked President Wilson to call a meeting of the league in general assembly in some European city next November.

SENATE GIVES ORDER FOR INVESTIGATION OF CANDIDATES EXPENSE

WASHINGTON, May 20.—Investigation of presidential candidates' campaigns of both parties, including their contributions and expenditures or use of influence, was ordered today by the senate.

A resolution by Senator Borah, Republican, Idaho, providing for an investigation by privileges and elections sub-committee was adopted without a record vote and with little discussion.

Baker Has Small Fires In Forests

BAKER, May 20.—Two small fires initiated the forest fire season in Baker and Grant counties last week, according to word received. Both were on Boulder creek, near Austin, and are said to have been started by sparks from logging engines. The total acreage burned was seven, but the damage was confined to young trees.

HUSBAND IS SHOT BY JEALOUS WIFE; SUICIDE ATTEMPTED

PORTLAND, May 21.—Mrs. August Bjorklund shot her husband, then turned a revolver on herself in their apartment at 678 Thurman street at 10:15 o'clock this morning.

Bjorklund will die, according to attending physicians at St. Vincent's hospital.

Mrs. Bjorklund's condition is said to be precarious.

The cause of her act was not discovered by the police. It is believed that jealousy was the motive.

Mrs. Bjorklund was wearing a picture of her husband over her heart when she and the wounded man were found by Lieutenant Kump of the fire department and Motorcycle Officer C. Wiles.

Bjorklund was shot in the head, Mrs. Bjorklund shot herself in the lungs.

U. S. LEAVES EUROPE TO WORK OUT OWN FINANCIAL TROUBLES

WASHINGTON, May 20.—President Wilson and his cabinet have decided that the allies and Germany must work out their own financial recovery unaided further by the United States, it was learned today.

This important decision is understood to have been reported at the cabinet meeting on Thursday. It is believed to have been precipitated by the financial agreement arrived at between Premier Lloyd George of Great Britain and Premier Millerand of France last Sunday at their conference at Hythe, England.

This agreement would heavily involve the United States.

MEXICAN CHIEF IS KILLED BY REBEL FORCES

MEXICO CITY, May 22.—Venustiano Carranza, the fugitive president of Mexico, and six of his followers have been killed in a skirmish with revolutionary troops under General Rodolfo Herrera, a rebel leader, near Tlaxcoapan, in the southern part of the state of Hidalgo, according to officially confirmed advices received by General Alvaro Obregon today.

It is believed that Ignacio Bonillas, former Mexican ambassador to the United States, who fled from Mexico City with Carranza, was among the others slain.

The revolutionary administration was advised that Carranza's body is being brought to this city. Herrera was formerly leader of a rebel faction known as Pelicistas. He surrendered to the government several months ago while Carranza was still in power. Several columns of Obregonian troops are now reported to be in pursuit of Herrera.

While reports as to the skirmish near Tlaxcoapan differed as to details, all agreed that Carranza had been killed. According to one report, all the persons in Carranza's immediate party were put to death.

COOS BAY INDUSTRIAL PLANTS ARE CLOSED BY CAR SHORTAGE

MARSHFIELD May 25.—The car shortage in this part of the state is becoming more serious for industries. State highway work between Coquille and Marshfield was Monday shut down for a week, because of lack of material which is bought, but cannot be moved without cars.

The Coquille Lumber mills at Coquille announced Monday a shutdown of 30 days because of car shortage and the Johnson mill at Coquille is closed. The Reedsport Lumber company, Winchester Lumber company and Johnson company plants at Reedsport have been closed because of no cars. The North Bend Mill & Lumber company began operations again Monday morning but only with a day shift.

The new camp of the Oregon Export company has closed down because equipment, ordered, cannot be secured. The mill of the same company started operation Monday morning, after a shutdown. If the car shortage is not relieved, other mills dependent upon rail shipment will be forced to close.

FRENCH PRESIDENT IS SAVED FROM DEATH BY RAILROAD STRIKE

PARIS, May 25.—President Deschamps will occupy rooms at the Chateau Rambouillet for at least ten days, there to recover from his harrowing experience yesterday morning when he fell from a moving train near Montargis. The chateau has not been occupied since President Fallieres was in office. The executive, says, the Echo de Paris, owes his life to the fact that the railroad strike brought about a suspension of a Paris-bound train due to pass the spot where the president took his plunge from the car at almost the exact time of the incident.

BODY OF CARRANZA IS SENT BACK TO CAPITAL OF MEXICO

MEXICO CITY, May 24.—A dingy little train of three wooden coaches today brought the remains of Venustiano Carranza back to his former capital.

Drawn by a rusty, crippled engine the train slowly puffed its way into the city at 5:50 A. M. on the narrow gauge railway.

Not more than 150 persons witnessed the arrival of the body. The faithful watchers included most of the foreign diplomatic corps. George Summerlin, the American charge, was conspicuous in a high silk hat.

G. O. P. INVOCATION MAY BE PRONOUNCED BY CARDINAL GIBBONS

CHICAGO, May 21.—Cardinal Gibbons, highest Roman Catholic dignitary in the United States, may pronounce the invocation at the opening of the Republican national convention here, it was reported today, following the action of the convention committee on arrangements in sending a telegram to the cardinal asking him to be present on the opening day, June 8.

Cardinal Gibbons will be in Chicago June 8 to take part in the seventy-fifth anniversary celebration of the establishment of the Chicago diocese and the silver jubilee of Archbishop Mundelein.

AMERICAN MONEY IS QUOTED LOWER IN MARKETS OF PARIS

PARIS, May 20.—Currency dropped in the Paris market this morning. The pound sterling opened at 48 francs and the American dollar at 12 francs, 59 centimes.

Yesterday's closing quotations were 53 francs for the pound and 13 francs, 74 centimes for the dollar.

A high official of the Bank of France expressed the view today that the sharp decline of the exchange rates meant the beginning of a return to the old equilibrium, ruled by the law of supply and demand.

RESOLUTION FOR PEACE PASSES HOUSE 227-139

WASHINGTON, May 21.—The house today passed the Knox peace resolution and sent it to President Wilson. It has already been passed by the senate.

The vote was 228 to 139. It indicates the resolution cannot be passed over the presidential veto as the majority is less than the necessary two-thirds.

Hissing by the Democrats broke out when Representative Mason, Illinois, Republican, declared that he "would rather take the judgment of the senate, than that of a sick man at the other end of the avenue."

Mason claimed that the president has no right to keep American troops in Germany.

ANNUAL SALES CLAIMED CAUSE OF PRICE DROP

SAN FRANCISCO, May 21.—Annual "cleanup" sales in every section of the country are "historically being mistaken for a downward movement in prices."

This was the interpretation given today by heads of the Manufacturers and Wholesalers association, which this week is holding a "buyers' week" in San Francisco, to the telegraphic dispatches from Eastern trade centers regarding "price reductions."

Prices are not coming down, it was emphatically stated.

S. L. Bernstein, chairman of the association, branded the wire dispatches as "hysteria."

There is nothing unusual about 20 per cent reductions, or even greater cuts. It happens every year in every store. Certain goods are held over. Styles change. There is a desire to sell out certain articles.

"There is no philanthropy," declared Bernstein; "it's just good business."

Railroad Earnings Last Year Small

WASHINGTON, May 24.—The nation's railroads earned only 1 per cent on their property investment last year, interstate commerce commissioners were told today at the opening of a hearing to fix new freight rates.

This statement was made by Howard Elliott, chairman of the rate commission of the Association of Railway Executives who began the argument on behalf of the roads for a general freight increase totaling \$1,017,000,000 annually. Under the transportation act, the interstate commerce commission must fix rates which will yield the roads a return of 6 per cent on their valuations.

The railroads now are confining their requests for rate increase to freight tariffs.

Pittsburg Bank Is Looted By Bandits

PITTSBURG, Pa., May 24.—Six armed and masked men entered the First National bank at Finley, just before noon today, and after beating John Jones, the assistant cashier, into unconsciousness, escaped in an automobile with \$150,000 in securities and \$15,000 in cash.

Jones was alone in the bank at the time. A posse was formed a few minutes after the robbery occurred and is reported to be close behind the bandits.

Draft Dodger Is Still At Liberty

PHILADELPHIA, May 25.—Military authorities, department of justice agents and the local police, all of whom are investigating the escape of Grover C. Bergdoll from army guards, apparently had made but little headway today so far as fixing responsibility or of obtaining a clue to the fugitive's whereabouts are concerned. No trace of Bergdoll has been found.

Auto Association To Probe Gas Shortage

SAN FRANCISCO, May 25.—"The why and wherefore" of the serious gasoline shortage confronting the state of California were to be delved into this afternoon at a meeting of the executive committee of the California State Automobile association.

Representatives of the Standard, the Association, the Union and the Shell Oil companies, who supply the greater part of the oil products used in the state, were to be presented.

Film Star Suffers Severe Injuries

LOS ANGELES, May 21.—William S. Hart, celebrated film star of the Western pictures, is suffering from severe injuries today as the result of an argument with a vicious horse during the filming of a movie scene. He has broken ribs, bruises and lacerations.

Hart was riding "double" behind another actor in a thrilling chase scene when the limb of a tree struck him in the face, knocking him from the horse. The animal, frightened as Hart dropped off behind, struck out with both iron-shod feet and kicked the star into unconsciousness.

Women Delegates Sail To Europe

NEW YORK, May 20.—Thirty delegates and visitors to the congress of the International Woman Suffrage alliance sailed from here Wednesday on the Royal George. They will go to Geneva, where the congress opens a week's session on June 6.

Mrs. Carrie Chapman Catt, nationally known suffrage leader, headed the party, which also included Mrs. Joseph Daniels, wife of the secretary of the navy; Helen Ring Robinson of Colorado, and others.

Twenty-six countries will send representatives to the congress.

Bank Is Looted By Armed Bandits

TOLEDO, O., May 20.—Six bandits today shot up the main street in Delta, O., near here, seriously wounded James Warner, a banker; invaded the People's Savings bank and escaped with \$12,000 in cash and Liberty bonds.

Townpeople scurried for shelter as the robbers sped through the main street in a touring car, shooting in all directions.

MAXMILLIAN HARDER PREDICTS REVOLUTION IN GERMANY SOON

BERLIN, May 25.—Another revolution in Germany within six or eight weeks, accompanied by a reactionary reign of terror, was predicted today by Maximilian Harder, famous editor of Die Zukunft.

"You can feel revolution in the air," declared the noted journalist. "The scenes are being set for it. It has been shown by the unsuccessful Von Kapp coup that plotters have nothing to lose if they fail, and everything to win if they succeed. The government has not punished a single person who took part in the Von Kapp uprising."

"The terror will begin with a camouflaged communistic revolution staged and paid for by the reactionaries. True, radical sympathizers will join the movement in the belief that it is a 'Red revolution.' But then the Army Officers' association will step forward as the saviors of the country and will launch their well-planned counter-revolution to put down the Reds, and the reactionary terror will be on."

PORTLAND BIDS FOR ELECTRIC LIGHT MENS' CONVENTION IN 1921

PASADENA, Cal., May 24.—New Orleans, Hot Springs, Portland, Ore., and Chicago are hot rivals for the honor of holding the 1921 convention of the American Electric Light association which has brought many of the millionaires of America to Pasadena. This, however, will not be decided until the executive committee meets some weeks later.

The officers who will serve for the ensuing year are:
President, Martin J. Insull of Chicago; first vice president, M. R. Bump of New York; second vice president, Fred W. Smith of New York; third vice president, Walter H. Johnson of Philadelphia; fourth vice president, Franklin T. Griffith of Portland, Ore.; treasurer, H. C. Abell of New York re-elected.

CARRANZA AUTOPSY SHOWS CLAIM OF SUICIDE IS FALSE

VERA CRUZ, May 25.—Reports of an autopsy performed on the body of Venustiano Carranza at Tlaxcoapan, O., fall to agree with the claim of Rodolfo Herrero that the president committed suicide rather than being taken captive. It is asserted in official quarters here.

Surgeons found Carranza had been struck by two rifle bullets, one of which penetrated his breast and the other his abdomen. The bullets entered from the front and it was the conclusion that the president had been assassinated.

MOTION ELIMINATES RESTRICTIONS ON AIR FORCES OF NAVY

WASHINGTON, May 25.—The senate upon the motion of Majority Leader Lodge eliminated from the annual army appropriation bill provisions restricting naval aviation to operations in connection with fleet movements and land bases. The eliminated provisions were opposed by Secretaries Daniels and Baker. The senate tentatively adopted an amendment proposed by Senator Wadsworth, authorizing sale of eight former transports, the Sherman, Sheridan, Thomas, Logan, Buford, Kilpatrick, Cook and Warren.

SEVENTEEN HURT IN INTERURBAN WRECK AT ASHLAND SUNDAY

ASHLAND, May 24.—Seventeen out of 19 passengers on an interurban car were injured Sunday when the car swerved from the track on the curve under the railroad overhead crossing one mile north of Ashland and dashed into a telephone pole.

The injured were taken to local hospitals.

R. Boswell of Grants Pass and Mrs. J. B. Wimer of Ashland were the most seriously injured. They were badly bruised.

NAVAL PLANS MADE IN 1915 DANIELS CLAIMS

WASHINGTON, May 24.—Naval plans for the prosecution of war against Germany were "ordered drafted" by Secretary of the Navy Daniels in 1915 and were perfected by the navy general board in February, 1917, Secretary Daniels today told the senate subcommittee investigating charges made by Admiral Sims.
