FRANKLIN C. DONOVAN
DIES THURSDAY NIGHT
AFTER LONG ILLNESS

Franklin C. Donovan, a well known resident of Oregon City, died at the family home at 901 John Adams street, Thursday night at 11:30 o'clock, after a lingering illness.

Mr. Donovan was born at Somerset, Ohio, September 13, 1860, and when a lad moved with his parents to Wisconsin, and later to Iowa. He married Miss Minnie Neitzel at Algona, Iowa, and in 1902 moved to Oregon City, where they have since made their home.

For ten years Mr. Donovan was employed in the paper mills, but owing to ill health over a year ago gave up his duties with the manufacturing company.

Mr. Donovan is survived by his wife, Mrs. Minnie Donovan, of this city; three children, Mrs. Josephine Forsberg, Miss Myrtle Donovan and Robert H. Donovan, all of this city. He also is survived by a brother, Edward W. Donovan, of Algona, Iowa; three grandchildren, George, Rhea and Robert Forsberg, of this city, and a cousin, Mrs. C. J. Cameron, of Aurora, Oregon.

SINGLE TAX PARTY

CHICAGO, July 9.—Plans of a group of liberal radical organizations for one unified third party, with candidates for president and vice-president in the field, received a setback today when single tax party members announced they would not support Senator Robert M. La Follette, who is expected to be the choice of the other groups.

The single-taxers who arrived today to prepare for their convention, which opens Saturday, declared they would bolt the combine and nominate a separate ticket if the majority chose La Follette.

While the single-taxers were threatening to present their own ticket, Amos Pinchot and George L. Record, of the committee of 48, were in Madison, Wis., today conferring with La Follette, who has received a majority of a mail straw vote of the party.

FIRE BOYS PLAN TO
ORGANIZE COMPANIES
IN ONE BIG BODY

About 40 firemen, representatives of all the companies of Oregon City, met at the fire hall Wednesday evening to discuss plans for the new organization that will be made when the city purchases the new fire truck and installs a paid department.

The firemen propose to keep the old department intact but to organize the companies into one body with the exception of the Elyville company, which for geographical reasons would be maintained at its present location.

It was proposed at the meeting to recommend that the paid fire department be placed under Civil Service regulations to the end that politics be eliminated and that applications for positions on the paid department be made to the water commission. The local firemen favor a three-man department, one to be named chief and to have one man on duty constantly.

It has been proposed that the chief name 10 of 12 men besides the paid department to be available at his call in fighting fire but the boys Wednesday night expressed their preference that the company be left intact and that they attend all fires as heretofore and that the paid chief be privileged to select such men as he deemed necessary in case of a blaze that the paid department could not handle alone.

As yet the council has made no selections for the paid department but the firemen recommended several names at the Wednesday meeting.

Sues To Collect
For Money Loaned

Bessie M. Dundas has filed suit against Martin J. Moran and Elizabeth Charters, his former wife, to collect \$1972.50 which he alleges he loaned Martin before his marriage. According to the complaint it is claimed this money was loaned and Moran gave a mortgage to secure the note and Elizabeth Charters claims some interest in the property on which the mortgage was given.

This money was to be paid in installments of \$250 per month and plaintiff claims only \$250 and part of interest has been paid and asks that the mortgage be foreclosed to satisfy her claim.

MANY ARE INJURED
IN STATE DURING
YEAR JUST ENDED

SALEM, Ore., July 12.—During the fiscal year ending June 30, 1920, a total of 21,378 industrial accidents were reported to the state accident commission, according to a statement just issued by the claim department of that commission. Of that number 157 were fatal accidents.

The monthly average for the year was 1768.41 accidents and 13.8 fatal accidents. The report shows that during the year the commission disposed of 1497 claims more than the total number received, this making an average monthly gain of 123.25 claims.

During the year twenty-six widows who were drawing monthly pensions because of the death of their husbands by industrial accidents, remarried. Of the twenty-six, twenty of them had children which continued to draw compensation. Under the provisions of the law the widows were paid a lump sum of \$300 upon remarriage and further compensation discontinued.

During the year the commission made final settlement of 13,520 cases 1940 cases were suspended, 323 claims were rejected, permanent partial disability awards were made in twenty cases, awards were made in seventy-six fatal cases, fifty-four fatal cases were suspended because there were no claimants, and twelve fatal cases were rejected.

Paper Mill Man of
Camas Is Suicide

PORTLAND, July 13.—Pat Driscoll, 40, committed suicide by jumping into the river from the Burnside street bridge at 5 o'clock last night. Driscoll was an employee of the paper mills at Camas, Wash. The police believe that he was under the influence of liquor at the time, as his name is familiar at police headquarters.

The body was recovered from the harbor police and turned over to the coroner. Driscoll left a note in the office of the Parr-McCormick Steamship company, 181 Burnside street, which was addressed to Mr. Crew, of Camas, and read: "I write these lines to say good-bye. I am on the Burnside bridge and about to do the 'duck act.' Look for Pat Driscoll at the morgue."

DIRECT TAX FOR ROADS
IS CLAIMED IMPOSSIBLE

It is not possible to see an early fulfillment of the cherished plan of Charles E. Spence, master of the state grange, to submit to the voters of Clackamas county the question of levying a county-wide direct tax for road improvement, according to J. W. Sipp, an Oregon City attorney, who said Friday there is no legal machinery by which such a plan may be submitted at the November election this year.

Mr. Spence is an ardent believer in the pay-as-you-go system of financing road building, and is opposed to road bonds, though he is willing, he says, to go into the country and make a vigorous campaign for a separate bond measure to finance the construction of a new bridge across the Willamette river at Oregon City. After the state supreme court refused to validate the \$1,700,000 road bond issue for Clackamas county, Mr. Spence proposed that the question of levying a direct tax of five or seven mills should be placed before the people at the general election next November, realizing a fund of from \$150,000 to \$210,000.

Mr. Sipp is certain that this cannot be done before the November election in 1922, for the reason that there is no legal machinery available. He believes that the initiative would have to be evoked through the office of the secretary of state, as other initiative measures are submitted, and declares that the time for filing initiative petitions for the coming election has passed.

The county court is giving favorable consideration to the idea of giving the people of the whole county, at the fall election this year, an opportunity to pass judgment upon a bond issue for a new bridge connecting Oregon City and West Linn. All of the members of the court are sanguine that such a bond issue would be approved. If the voters were educated as to the gravity of the situation, and the probability of closing the present unsafe structure to travel.

BODY OF LOST
FISHERMAN IS
FOUND SUNDAY

The body of David R. Thomas, of Portland, who was drowned while fishing near the falls April 29, was recovered from the Willamette river Sunday, and removed to the Holman & Pace undertaking establishment in this city, and shortly after turned over to the Finley undertaking establishment of Portland, arrangements having previously been made by the mother, Mrs. M. Thomas, widow of the late Dr. Thomas, of Portland, in case the body was ever found.

As William Smith, of Parkplace, and another employee of the Crown Willamette Paper company were working on a tower of the paper company about 75 feet from the roof of the building, Smith's attraction was drawn toward the river and at once saw the body floating. The two men hastened down from their work and ran to the water front, where they secured a skiff, but which had no oars. They managed to get several boards and used these for paddles, and after trying the body, started toward the east side shore, where had intended turning it over to the coroner. While making their way down the river, Tom Brown and his son, George, assisted the men, and brought oars. The body was taken to the undertaking establishment, and soon found to be that of Thomas, as the fishing license and his watch were found in his clothing. The body showed the results of the long time in the water. At the time of the finding of the body the mother was visiting relatives at Pull Run.

Mr. Thomas had come to Oregon City April 29 in company with Evan R. Thomas, also of that city, and son of Mr. and Mrs. T. C. Thomas, whose home is located at Mount Pleasant, about two miles from this city, to fish and shortly after leaving the boat house their boat was found full of water some distance from the scene where the men were supposed to have gone on their fishing trip. Every effort had been made to recover the bodies, and that of Evan Thomas was found floating in the river seven days after the accident occurred.

It is believed that the men had gone to fish near the falls close to the dock of the Hawley Pulp & Paper company and that a swift current caught their boat and capsized it and they were washed beneath the dock and later were carried out in midstream. The current at that place was unusually dangerous during the fishing season. This was near the point where Albert Lettenmaier, a paper mill employee, was drowned while fishing for salmon about the same time.

The Thomas men were old time friends, both formerly residing in Clackamas county. David Thomas was about 37 years of age, single, and made his home with his mother, being the only living child. His father was the late Dr. Thomas, formerly of Reasor Creek. Evan R. Thomas was married and left a wife and daughter, besides his parents and two sisters, Mrs. Lizzie Davis, of Idaho; Mrs. Owen Thomas, of Mount Pleasant; and two brothers, David H. Thomas, of Mount Pleasant, and T. J. Thomas, of Portland.

MANY ARE PLANNING
TO ENTER DISPLAYS
AT CLACKAMAS FAIR

David Long, secretary of the Clackamas County Fair Association, whose home is in Hazzella, was in this city Monday on business pertaining to the fair, which is to be held in September at the Clackamas county fair grounds at Canby.

Mr. Long says there never has been a larger demand for commercial displays than for the coming event, and from the present indications he believes the fair will even be better than that of last year, which was considered one of the best ever held by the association. So far no arrangements have been made with a carnival company, but several have asked for concessions.

Mr. Long is now one of the busiest men of the county in getting ready for the fair and harvesting his crop of cherries at his home. Already two tons of the Royal Anne have been harvested and shipped to Portland, and three tons are still on the trees. Mr. Long has a crew picking the cherries, but Monday's rain put a temporary stop to the work. His black cherries are the Bing and Lamberts, exceptionally fine quality this year. Mr. Long expects to have a large yield of these varieties unless the rain drenches them so as to cause them to crack, and they will be sold outside of the firm that has been contracting his Royal Anne cherries. Two large truck loads of cherries were shipped out of Oswego Monday morning from the Long orchard and others engaged in raising cherries in that section.

The women pickers are making good as well as the men, and are receiving in most yards three cents per pound. One girl on the Long place is averaging \$6 daily, while another is making her \$3.75 each day.
