Figgs And Living Costs

The office of A. Mitchell Palmer, attorney general of the United States, is showing signs of actual activity in the enforcement of the Lever law against profiteering, that manufacturers and jobbers of wearing apparel were attempting through carefully prepared propaganda "to stamper retailers and the public into a renewed fictitious demand" for clothing, and thereby force prices higher.

We're glad to note these appearances of rejuvenation, so soon after the San Francisco convention. Mr. Palmer's office has not covered itself with glory since the Lever law was enacted, and has failed to satisfy the public with the excuse that additional laws were necessary before prosecution could be successfully undertaken. We wish Mr. Figg and his associates every success in his campaign against the profiteers.

There is bound to be charges and counter-charges of profiteering, however, so long as the country is kept on a war basis. Stabilization is badly needed. While we cannot expect to return to pre-war prices, we may well expect a return to a condition where we may know from one month to another what we shall have to pay for the necessities of life. Otherwise, there can be no general prosperity and certainly no contentment.

Before the war we knew that prices for staple commodities would fluctuate with changing seasons, but not to a great extent. Supply was fairly met by demand, and wage and living conditions were so steady that it was possible to plan ahead and work intelligently to a definite goal. Until these conditions are restored, there will be no general satisfaction throughout the land. The department of justice should vigorously prosecute all cases of profiteering in every line of industry, but that will not bring prices down nor will it keep them from advancing. This is the age of manipulation, the direct antithesis of stabilization and standardization. We must cease chasing the dollar around in a circle or living costs can never be reduced.

FLOUR PRICES DROP 80 CENTS BARREL, MEATS TAKE ADVANCE

PORTLAND, Aug. 2.—Flour is dropping fast, cooking fats are dropping and soon a drop in the price of bread may be expected.

One of the most severe declines known in the milling trade for an extended period was shown in the market today, when millers announced a cut of 80 cents a barrel in the price of all grades of flour. This put the wholesale price of patent grade to \$12.95 at the mills, or 15 per cent additional for delivery to retailers.

The drop in price amounts to 20 cents a sack to consumers, for the 40-pound offerings, and 40 cents a sack for the 98-pound packages.

The new prices are now in effect and consumers should get the immediate benefit.

Flour prices dropped this season before for the normal period for adjustment. Usually millers make the change from the old to the new crop producer, when the new stock is ready for delivery, but the drop this season is made while the old crop is still available.

The new price, therefore, places flour quotations on the basis of the sharply lowered price of wheat, and consumers are given immediate benefit of the changes.

Meat prices, on the other hand, are soaring. Pork and beef are both advancing, and it begins to look as if the aviating process has merely begun.

In the meantime the price of potatoes is dropping.

Petition Is Ignored To Force Peace

WASHINGTON, July 28.—Because no demand had been made on Secretary Colby to promulgate the resolution ending the state of war with Germany before the filing of the suit for mandamus by Harry S. McCarney, a Chicago lawyer, Chief Justice McCoy of the district court refused today to hear argument on the petition.

The court continued the matter until tomorrow to let the petitioner decide whether he should make the formal demand on Mr. Colby and amend his petition to show that such a demand had been made or have the petition dismissed as defective.

Canby People Give Aged Woman Aid

CANBY, July 29.—Mrs. M. Jackson, also known as Mrs. Jerry Jackson, who asserts she is nearly 80 years old and that she came from Salem by being a ride in an automobile, was aided by Canby citizens, who raised money to send her to Astoria, where she said she has relatives. A purse was raised at a meeting of the Commercial club. She said her pocketbook, with all her money, was stolen in Salem.

ALASKA RATES DEDUCED

WASHINGTON, Aug. 4.—Freight rates on the government-owned railroad of Alaska have been reduced on less than carload lots. Secretary of the Interior Payne announced today on his return from Alaska.

Rates on less than carload lots were found to be twice high as on carloads, he explained, and as the government line is not operated for revenue they were lowered to within 25 per cent of the carload rate.

National Airplane Race Is Planned

NEW YORK, July 29.—A trans-continental airplane race to be known as the national airplane race, for the Pulitzer trophy, and cash prizes, will be held in October or the first week in November, the contest committee announced tonight. The route will be that of the United States mail service between New York and San Francisco.

Aviators who take part in the international airplane race in France during the week of September 27, the committee stated, are expected to be contestants.

ST. LOUIS PUBLISHER DIES
