CLEVELAND WINS FIRST GAME FROM BROOKLYN

NEW YORK, Oct. 5.—The Cleveland American league club today defeated the Brooklyn National league team 1 to 1 in the initial game of the world series today.

The victory, which was far from impressive, was won by a team play, sparkling with brilliant individual work on the part of Indians, which made the efforts of the Superbas dull by comparison.

The opening contest was witnessed by a throng of baseball fans which tested but did not overflow the normal precincts of the Ebbets field.

According to official figures of the national commission, 23,373 persons paid admission to the Brooklyn park, while at least another thousand can be added when the newspaper men and other semi-official representatives are included.

The gate receipts were announced as \$79,049. In both attendance and receipts these figures surpass the best individual game record made at Brooklyn in the series of 1916.

Both the team and individual play of the winners was superior to that of Brooklyn. Cleveland pitched a masterly game and held the opposing players in check throughout. He was backed by perfect fielding of both infield and outfield.

Cleveland batters found Marquard easier to hit than either Marmora or Cadore. The Indians failed to get a runner on first after the close of the fourth inning, going out in order for the remainder of the game.

A comparison of the pitchers shows that Cleveland threw the ball up to the batter only 85 times in nine innings, while the total for his three Brooklyn opponents was 112. Marquard threw 80 times in six innings, Marmora 26 in two and Cadore six in one.

BUREAU OF NURSING REPRESENTATIVE IS CLACKAMAS VISITOR

Miss Helen Hartley, representing the state bureau of nursing, with headquarters in Portland, was in Oregon City Monday, having come here in the interest of the work carried on by the county health nurse, Miss Isabel Burns. Miss Hartley accompanied Miss Burns to several of the places where she has given talks on the subject in which she is engaged, and was very favorably impressed with the work. Miss Burns was accomplishing.

Clackamas county makes 14 counties in the state having the county health nurse, and twelve more are awaiting for nurses to be sent. There are nine understudies enrolled, and it is probable that an understudy will be sent to under the direction of Miss Burns.

The people of Clackamas county have been enthusiastic over the work of Miss Burns, and have called upon her to visit their sections of the county. During the county fair she established quarters with the Red Cross rest room.

On Friday Miss Burns assisted Dr. H. A. Dedman and Charles Sheldon of Canby, in vaccinating 16 students of the Canby high school as a prevention of smallpox that has broken out in that city, where two of the school students are afflicted. One of these being of the high school. So far there are no other families afflicted.

Miss Burns made another trip to Canby Monday afternoon in company with Miss Hartley, and will address the school at Union Mills Friday afternoon and on October 11th will go to Oak Grove.

ALBRIGHT PETITION IS FORCED OFF BALLOT BY ILLEGAL SIGNERS

The petition of J. F. Albright for a franchise to operate jitneys from Oregon City to Portland, will be kept off the ballot at the November election, according to city officials, on account of a number of the signers of the petition not being registered as voters. Of the 204 signers of the petition it is claimed that about 60 are illegal.

FORMER EMPLOYEE OF W. V. S. RAILWAY IS KILLED IN ACCIDENT

Hugh Foster, well known in Oregon City, where he resided for a number of years, and employed by the Willamette Valley Southern Railway company, but who has been for the past month employed by an oil company with headquarters at Casper, Wyoming, died Saturday afternoon from injuries received in an automobile accident that occurred Friday afternoon while with a party returning from the oil fields. Among those with Mr. Foster at the time was a Mr. Green, of Portland, who was also interested in the oil company.

Word was received by Mrs. Ella Foster, of 5305, Portland, telling of the accident, and stated that her son would undergo a surgical operation Friday evening in order to save his life. Edwin Foster, brother of the young man, who is traffic manager of the Willamette Valley Southern railway company here, and whose home is in Portland, left upon receipt of the telegram announcing the accident, and was on his way when the other received a telegram telling of the death in a hospital at Casper.

The remains are to be brought to Portland for burial, and will arrive in that city about Thursday. The time set for the funeral services have not been definitely made, but will be at the Holman funeral chapel in Portland, with interment in the family lot in the Masonic plot of Greenwood cemetery, and laid to rest beside those of his father, Edwin Foster, Sr., who died in Portland in 1911.

Mr. Foster was born at Independence, Kansas, September 15, 1879, and resided in Portland for a number of years before coming to Oregon City. He returned to Portland about a year ago, and recently left for Wyoming. Mr. Foster had many friends in this city and in Portland, and was well and favorably known along the Willamette Valley Southern Railway, having charge of a construction camp for some time during the construction of the railway line.

Mr. Foster is survived by his mother, Mrs. Ella Foster, of 5305 41st Street Southeast, Portland, and Edwin Foster, a brother, of Portland.

LIVE WIRES HEAR PLEA FOR RELIEF OF ARMENIAN SUFFERERS

The weekly luncheon of the Live Wires Tuesday was addressed by F. E. Bronson, state chairman of the Near East relief committee, who asked the cooperation of the club in securing clothing to be shipped to the Armenians. The W. C. T. U. rest room will be available as a place for assembling the donations, and Main Trunk Edgar appointed C. H. Dyer, Rev. C. H. L. Chandler and Arthur Rugg a committee to assist. Mr. Edgar is county chairman of the work.

M. D. Latourrette, reporting for the Taalain river committee, said that in company with a government engineer the committee had investigated the river on both sides, and that it appeared impractical to open it to navigation, was the proposal. Two locks, costing a half million dollars, would be required, and due to the little traffic expected the appropriation will not be favored by the engineer. The proposal to open the river was introduced into the club by Warren G. Thatcher, of Hillsboro, who claimed that many acres of land now submerged would be reclaimed for agriculture if the river was improved.

The announcement that the road bond issue had been finally decided illegal by the state supreme court was made by Oscar D. Eby, one of the leaders in the campaign and the attorney who argued for their validity before the supreme court two months ago. The club decided to take no action at this time in regard to floating another issue, as it was stated the next legislature may make some changes in the present 6 per cent limitation law, which was invoked against the Clackamas issue.

F. K. Lane Forced To Give Up Work

NEW YORK, Oct. 2.—Franklin K. Lane, ex-secretary of the interior, has been forced to give up business temporarily because of ill health, it was learned today.

It was said at the offices of the oil company of which he is vice-president that, approaching a physical breakdown after seven years of public life, he had been ordered by his physicians to leave his desk two weeks ago. He went to Ketchikan, N. Y., returning here yesterday on his way to Bethel, Maine, where he has been directed to take a complete rest. His condition now, it was said was not serious.

MOTION ON BOND ISSUE REHEARING IS OVERRULED

The Supreme Court of Oregon has overruled a motion of Clackamas county asking a rehearing on the \$1,700,000 bond issue which was declared invalid in a decision of the court and as far as that issue is concerned the case is ended.

Several other counties were interested in the case as they had voted bonds under the same ruling as Clackamas county, some of them even issuing and spending them.

Under the laws of 1913 a county was given authority to issue bonds for two per cent of their valuation and in 1919 a constitutional amendment was passed whereby a county could vote bonds up to six per cent of their assessed valuation.

The six per cent bonds were voted in this county but before they were issued the question of their validity was taken to the supreme court and the court ruled a county could not issue bonds up to six per cent under the machinery used for the two per cent bonds. They ruled that it would be necessary for the legislature to pass additional machinery to float these new bonds.

The \$1,700,000 bond issue was for hard-surface roads in Clackamas county and the ruling of the supreme court put a stop to much of the work contemplated here this year.

G. M. BROWN IS NAMED SUCCESSOR TO BENNETT

SALEM, Or., Oct. 1.—George M. Brown, since January 1, 1915, attorney-general of Oregon, tonight was appointed justice of the Oregon supreme court by Governor Olcott to succeed A. S. Bennett, who has resigned because of private business affairs needing his attention in Eastern Oregon. Attorney-General Brown will be succeeded by T. B. Handley, who was named corporation commissioner last May following the resignation of H. J. Schulerman. Mr. Handley's successor will be appointed by Governor Olcott tomorrow.

In presenting his resignation to Governor Olcott late this afternoon Justice Bennett said:

"I regret exceedingly to break the pleasant associations which have surrounded me on the supreme bench and to give up the very congenial work thereof. But the cares and disabilities of advancing years, together with the pressure of some private affairs, make it difficult and sometimes almost impossible to satisfactorily perform the duties of the office."

Attorney-General Brown was elected to his present office in November, 1914, and entered upon his duties on January of the following year. He was re-elected to the office at the general election in 1918 and had more than two years yet to serve.

Daughter of Secretary of Labor Who Seeks Father's Old Seat in Congress

His daughter, Miss Agnes Hart Wilson, has just announced her candidacy for congress from that district. Miss Wilson has been prominent in Washington social circles since her father's appointment.

ALLEGED MURDERER WILL BE PROSECUTED BY OWN SON-IN-LAW

BEND, Oct. 1.—Backed by the approval of his wife, A. J. Moore, district attorney of Deschutes county, will leave no stone unturned to convict Jack Weston, Mrs. Moore's father, of a charge of first degree murder. Moore announced his position Friday morning when Weston, a rancher, was arraigned.

Weston was arrested Thursday charged with slaying Robert H. Krug, 70-year-old hermit farmer, whose body was found in the ruins of the Krug cabin, four miles from Sisters, in March, 1919. Weston's preliminary hearing has been set for Tuesday by Justice of the Peace Eastas. It was understood he will plead not guilty.

District Attorney Moore was present at the arraignment of his father-in-law and declared that the fact that his wife is Weston's daughter would not interfere with his conducting the prosecution. He will leave no stone unturned to secure a conviction he said.

ENGINEER AND MACHINIST DIE IN HOTEL FIRE

HUNTINGTON, Or., Oct. 5.—William Travers, division engineer of the Oregon Short Line, and Roy Cornelius, motor car machinist of the same road, both of Pocatello, Idaho, were burned to death last night in a fire which destroyed the hotel at Robinette, Or., forty miles down the Snake river from here.

P. E. Parsons, Nampa, Idaho, an Oregon Short Line superintendent, was severely burned and escaped immediate death by jumping from an upstairs window. His condition was reported critical.

Patrick Brennan, Weiser, Idaho, and Mrs. C. O. White, whose home is near Cambridge, Idaho, also jumped and suffered injuries.

J. B. McBride, formerly of Salt Lake City, who operated the hotel, was seriously burned.

Several other persons suffered burns and minor injuries.

A large dwelling house near the hotel was destroyed by fire.

A special train was made up here and doctors and nurses were taken to Robinette.

Mrs. White was taken to a hospital at Weiser and the injured men were taken to a hospital at Boise.

PROMINENT REPUBLICAN STATESMAN PASSES ON

DALTON, Mass., Oct. 2.—Winthrop Murray Crane, ex-United States senator, former governor of Massachusetts, and leader in the national councils of the Republican party, died today at the family home here, where he was born 67 years ago.

Members of his family and Dr. Bruce W. Paddock of Pittsfield were at the bedside of the statesman when the end came. Death was caused by a general breakdown and heart trouble. In the words of Senator Crane himself, "something gave out."

Statements of tribute to the memory of Senator Crane came from all sections of the country today. The tribute of Governor Coolidge—"a great man has passed."

The illness of the former senator began on July 31 at Northampton, Mass., when he collapsed to the ceremonies notifying Governor Coolidge of his nomination as Republican nominee for vice-president.

Senator Crane's last public appearance was on August 13, when he attended a gathering at the Pittsfield Park club to hear Chauncey Depew in his "Friday the Thirteenth" address.

He announced shortly before the Republican convention, which he attended as a big four delegate, that he would retire from active politics upon the conclusion of his term as national committeeman.

BOYS AND GIRLS OF CLACKAMAS COUNTY WIN AT STATE FAIR

Clackamas county boys and girls made a record at the state fair at Salem last week, when twelve boys and girls of the county will be given the privilege of taking a course at the summer school for two weeks at the Oregon Agricultural College in 1921. These boys and girls are jubilant over the award of the judges, and they need be for this is the first time in the history of the state fair where so many of the girls and boys have made good from one county in placing exhibits in the juvenile department.

Oregon Voter Editor Criticizes Bills

PORTLAND, Oct. 1.—Numerous measures on the November ballot were criticized Thursday by C. C. Chapman, speaking at the weekly luncheon of the Portland Press club. Chapman, editor of the Oregon voter, put in objectionable class the single tax, anticompany vaccination, state supervision of marks, the 4 per cent interest rate amendment and a split legislative session. The oleomargarine bill was styled "foak legislation" and the Port of Portland measure was pointed out as desirable but containing no new points.

Provisions to increase the term of certain county officers and preserve the Roosevelt bird reservation received his unqualified indorsement. In speaking of the proposed state market master Chapman declared the bill too "full of teeth" to work out as successfully as the one California has and said it was desired only by cooperative leagues that have not been successful.

OWENS AND RATHIE TO PAY LIFE FOR CRIME

PENDLETON, Or., Oct. 5.—Guilty of murder in the first degree as charged in the indictment was the verdict returned at 3:30 o'clock this afternoon by a circuit court jury sitting in the trial of Elvie D. Kerby, alias Jim Owens, and John Laffeban, alias Jack Rathie, two of the five men indicted for the murder of Till D. Taylor, sheriff of Umatilla county, on July 25 last. The verdict closed the last trial of the five conspirators who planned to break jail and shoot their way out to freedom, and of the five three go to the gallows and two have been sentenced to life imprisonment.

Judge Phelps of the circuit court will Friday sentence the men found guilty today. The judge allowed the defense five days to file motion for a new trial and 50 days to file a bill of exception.

Two hours deliberation was all the time taken by the jury in reaching their verdict, following the receiving of instructions of the court, after hearing the closing arguments presented in court this morning. Attorney-General Brown, making his last appearance as prosecuting attorney, marshalled the evidence for conviction in a strong plea for a verdict of guilty in closing the case of the prosecution this morning. It was during the progress of this trial that he was informed of his elevation to the state supreme bench.

TWO HUBBARD MEN ARE INJURED AND CAR IS WRECKED

Owing to the slippery condition of the highway near New Era and in bringing their automobile to a sudden stop, Sunday afternoon Adam Garren and Fred Wolfow, young men of Hubbard met with an accident, when their automobile was completely turned over, and the young men thrown out. Garren is suffering from severe cuts on the face and bruises on his body while his companion, Wolfow, is suffering from internal injuries and bruises on his body.

The young men are now at the home of Garren's sister, Mrs. H. A. Bower, of Fourteenth and Madison streets, where they are being given medical attention.

Mr. and Mrs. H. J. Bigger and daughter, Mrs. Adrie Askew, of this city, who had been at the state fair grounds, at Salem, and were on their way home arrived at the scene of the accident shortly after it occurred, and gave assistance, bringing Garren to this city to the home of his sister, and Wolfow was brought in another car. The automobile in which they were riding was a wreck.

Although the young men have been confined to their beds since the accident, they were improving from their injuries Monday afternoon, and were able to leave their rooms, but will be several days before they will be able to return to their homes.

The road where the accident occurred is usually slippery during the rainy season, and care must be made by the drivers in passing along that section. The automobile carrying Wolfow and Garren was going at a moderate speed both men claim.

FOREIGN COUNTRIES ASK SETTLEMENT FOR LOSSES IN MEXICO

CHICAGO, Oct. 1.—Business men with property in Mexico were discussing yesterday the news from Washington that England and France were pressing claims for \$100,000,000 each against the United States for English and French losses during the Mexican revolutions.

When Mr. Wilson told the European powers to keep out of Mexico, saying he would manage the revolution, they agreed to do so on condition that the United States assume all liabilities for losses.
