## FIVE MILLION IS OFFERED LEGION BY K. OF C. DIRECTORS

CHICAGO, Oct. 6.—The board of directors of the Knights of Columbus Sunday voted to offer the American Legion \$5,000,000.

This is the balance of the \$40,000,000 collected by the organization for war purposes, to erect a memorial building in Washington.

The building, which would be in memory of the Americans who died in the war, would contain an auditorium seating 20,000, quarters for the Veterans of Foreign Wars, the Grand Army of the Republic the Spanish War Veterans and similar societies. Ownership of the structure would be vested in the American Legion, and it would be governed by a board of directors. Of the funds offered, \$1,000,000 would be used as an endowment or upkeep of the building.

A committee has arranged to meet Colonel Galbraith, new head of the legion, in New York soon to make the proposition to him.

## CASE IS TRIED TO OUST FARMER RENTER

A. M. McCallam filed suit some time ago against Joseph Crawford to plaintiff near Scotts Mills, which Crawford had leased for five years and was sold by McCallam recently, and the case was tried in Justice Stupp's court Wednesday.

According to the complaint when Crawford leased the place it was agreed that he should receive \$500 from the owner providing it was sold during the term of the lease. ## WILSON PROMISED FOREIGN COUNTRIES MILITARY AID IS CHARGE OF SENATOR REED

KANSAS CITY, Mo., Oct. 6.—After asserting that President Wilson had made a statement at the peace conference promising Roumania and Serbia military assistance under the proposed league of nations covenant, James A. Reed of Missouri, United States senator, democrat, late today sent a telegram to Senator Selden P. Spencer, his republican colleague, declaring that the statement was a matter of record and suggesting that the president produce the stenographic reports of the peace conference showing "just what was said."

Senator Reed's telegram was in response to one from Senator Spencer asking information on the subject. Senator Reed's message declared the statement was made by the president in an address before the peace conference May 31, 1919, but "did not get by the censor," until December 3, 1919, when it was brought to this country by a newspaper correspondent and published in the Washington Star of that date.

"The speech also appeared in full in the Congressional Record of December 4, 1919," the telegram continued, adding that it also was copyrighted by a newspaper syndicate and given wide circulation throughout the country.

"On several occasions I called the attention of the senate to this speech," the telegram said. "My speeches by scores of thousands were circulated through the country. Numerous publicists and speakers have repeatedly referred to and commented upon this declaration.

"Its authenticity was never disputed in the senate or elsewhere by my knowledge until Mr. Tumulty recently denounced it as false. The speech bears upon its face evidence of its authenticity, as it is couched in the well-known phraseology of the president."

## Defeat Charged To Woman Suffrage

SPRINGFIELD, Ill., Oct. 5.—Charging his defeat to the account of woman suffrage, Robert H. Burke, defeated by Peter A. Walker, Kewanee for the democratic nomination for United States senator, today filed a certificate of contest with the secretary of state.

He declares his defeat was brought about by the "illegal voters of the female sex."

## FLOUR AND BREAD DOWN.

SAN FRANCISCO, Oct. 5.—Following a reduction of 40 cents a barrel on flour, one baking firm announced the return of the 15 cent loaf of bread today. Other firms are selling the pound and a half loaf for 17 cents, but are expected to follow suit and reduce the price.

NEW YORK, Oct. 5.—Mrs. Calvin Coolidge was the guest today at a reception arranged in her honor by the republican women's state executive committee.

U. S. REJECTS OIL LAND MEXICO CITY, Oct. 5.—Petroleum concessions recently given to Alfred Mackenzie, a British subject, in Lower California, has been investigated and rejected by United States oil operators, according to newspapers here.

Inquiry develops the fact that United States corporation control twice as much territory in Lower California as has been turned over to the British.
