

HE average American citizen does not take the interest he should in the question of THE ELIMINATION OF POVERTY, because our poor classes are different in race and color from the most of us. In the north the poor classes are composed of the recent immigrants who have not yet been able to make a living or who have failed to succeed in the new country, and in the south they are our negro brethren.

OBVIOUSLY WE SHALL NOT PUT AND END TO POVERTY BY LEGISLATION, MUCH LEGISLATION IS NECESSARY, BUT NO CHANGE IN TAXATION OR IN THE DEGREE OR METHOD OF STATE CONTROL CAN EVER GO WHOLLY TO THE ROOT OF THE TROUBLE. 6 to 6 1-2c.


