

S. P. WILL RUN NEW ELECTRIC LINE SOON

PORTLAND, Ore., Oct. 21.—According to official announcement given out today at the office of Robert E. Strahorn, president of the Portland, Eugene & Eastern Railway company, the Southern Pacific, parent company, will after November 1 handle all operating and traffic matters connected with the new electric system until actual electrification has taken place.

Ordinance No.— An Ordinance adopting the report of Viewers of Damages and benefits for the establishing of a street on the bluff between Sixth and Seventh Streets, Oregon City, Clackamas County, Oregon, and the appropriation of the land necessary therefor.

Whereas, the committee appointed to assess the damages and benefits for the condemnation and appropriation of land to establish a street on the bluff between Sixth and Seventh Streets have made their report and said report appears to the Council to be just.

Therefore, Oregon City, does ordain as follows: Section 1. Sept. 11th, 1913. To the Hon. Mayor and City Council of Oregon City, Oregon.

We, your committee to whom was referred the matter of the condemnation and appropriation of land for the purpose of establishing a street on the bluff between Sixth and Seventh Streets, Oregon City, Clackamas County, Oregon, and the appropriation of the following described land:

Beginning at a point two (2) feet southerly from the northeast corner of Lot 1, Block 24, and on the property line of High Street, thence five (5) feet on a line 45 degrees to the right from High Street to the B. C. of a curve having a radius of 331.1 feet, thence on said curve 245.2 feet, more or less to the E. C. of a curve to have of the southern angle of 42 degrees, 36 minutes) thence on a tangent to said curve at said E. C. 48 feet more or less to the North line of Sixth Street, at a point 103 feet from the west line of High Street, owned by Sarah A. Chase, hereby make the following report:

Persuasive to notice thereof duly given us by the City Recorder of said Oregon City, we met on the 11th day of September, 1913, at lots 1, 2, 3, and 4, Block 24, at one o'clock p. m. for the consideration of said matter, Mrs. S. A. Chase being present in person and by her attorneys J. E. Hedges and C. D. Latourette, and proceeded to examine and view the said street and the premises to be appropriated for, and after making a careful examination of all the property damaged and benefited thereby and after considering all the matters in connection with the said street, we found as follows: To-wit:
