Consultant hired for county manager review

At the request of County Manager Scott Somers, the Clatsop County Board of Commissioners selected a third-party consultant to conduct a 360 performance evaluation of Somers.

Kennedy Consulting, a Portland-based firm with more than 25 years experience, was selected out of a crop of three candidates Wednesday by the Board of Commissioners at its regular meeting.

The firm, led by consultant Michelle Kennedy, was recommended by Association of Oregon Counties Executive Director Mike McAthur,

who said Kennedy previously helped the AOC.

Kennedy Consulting's 360 review will collect input from county staff, department heads and possibly community members and other people who surround Somers.

"She did a great job for AOC. Really good work," McArthur told the Board of Commissioners. "She works all across the country on these kinds of projects. She came to me recommended by Marion County."

Somers became Since county manager in 2012, his employment contract states the county must perform "facilitated review," or а third-party review. However, Somers and the Board of Commissioners decided to forgo such reviews deeming it not necessary and a way to save money. The Board of Commissioners held its own annual performance review at essentially no cost. Each review concluded positive feedback of Somers.

Hiring Kennedy Consulting will cost the county between \$10,000 and \$12,000.

The third-party review is necessary this year, according to Somers and the Board of Commissioners.

In recent months, Somers had been the focus of complaints in anonymous letters sent to the Board of Commissioners and The Daily Astorian that question his management style.

He has admitted a large number of changes have occurred in his time as manager. Since March 2013, at least six department heads have left the county.

County Clerk Former Maeve Kennedy Grimes was fired in December after errors were discovered on the general election ballot. In addition, half the county staff were moved to higher deductible health plans and the Juvenile Detention Center closed.

Somers believes the 360 review may put the concerns to bed.

Because of the concerns raised, Chairman Scott Lee

said, the Board of Commissioners felt it is appropriate to spend the money on the 360 review. The Board of Commissioners can choose not to do a third-party review in future years, and go back to it's regular review.

A review from the Board of Commissioners will be included in the 360 review this year.

"This is not something we are signing onto each year,' Commissioner Sarah Nebeker said.

In other business:

 Clatsop Care Center Social Services Director Mindy Stokes was appointed to the county's Human Services Advisory Council.

• The Board of Commissioners appointed a Project Advisory Committee for a Tsunami Hazard Overlay Project. The project will develop a plan for a Cascadia event and increase public involvement.

· The Board of Commissioners approved an agreement with the Oregon Judicial Department for \$100,000 to fund improvement projects at the county courthouse. The total project cost is \$198,320 to replace the roof, install a new backup generator and add exterior video surveillance cameras. Under the agreement, the OJD will cover 50 percent of the cost of the projects.

County Fisheries Project seeks fin-clippers

Clatsop County Fisheries Project is seeking residents for temporary employment with the Oregon Department of Fish and Wildlife to clip fins of salmon fingerlings.

The work will be done at the Clatsop County Fisheries' Astoria Yacht Club net pen facility and South Fork Klaskanine Hatchery.

Fin clipping involves utilizing scissors

to clip various fins from juvenile fish. The position requires good eyesight, dexterity, ability to stand in one spot for long periods of time, ability to handle small fish, good hand-eye coordination, ability and willingness to work in damp and cool environments, and ability to enter and leave premises without assistance. The job runs about eight weeks beginning around April 6.

Starting pay is \$12.17 per hour, hours are Monday through Friday, daytime shifts of up to eight hours, with biweekly paychecks, according to the Fisheries Project

On Feb. 22, Warrenton Police responded to Auto Zone, where Swint was attempting to purchase items using a personal check on his account. When the check was declined, Swint suddenly left the store. Officers attempted to contact Swint to see if the check was stolen but could not find him.

On March 6, Warrenton Police were called to Costco to a report of five bad checks written between Feb. 22 and 24 on an account of Robert Swint.

In checking the database, it was discovered that three bad checks were written to Englund Marine in Astoria between Feb. 20 and 21.

The Astoria Police report showed that Swint was identified by Englund Marine employees as the subject who presented the checks and received merchandise.

ready accepted a check from Swint and it has been returned, police are encouraging businesses to follow the Clatsop County District Attorney's Office bad check reporting protocol and then report it to local law enforcement.

The protocol includes these tips:

• Use automated check verification if available;

• The customer's complete name and address must appear on the check; • The check date must

be current. Do not accept postdated or future-dated checks;

• The check must have a bank identification number, or routing transit number that runs across the bottom, along with the customer's account number and check number:

• The "Pay to the Order of" section must indicate the business' name;

• Both the written and numeric amounts must match;

• The check should be signed in the business? presence and verified with photo identification; • Write the number of

any photo identification used on the check.
