The Holiday Inn Express is located in the Bridge Vista phase of the city's Riverfront Vision Plan. Some residents have complained about the potential reduction of river views and access to the Astoria Riverwalk if additional development is encouraged in the area.

But commissioners said that while the hotel will be larger, the expansion, like the original hotel approved in 2003, is consistent with the typical height for a historic hotel and many architectural details of nearby historic structures.

The demolition of the former sign shop could also open up views of the river. "We're going to open up another vista and I think that will make a majority of the community very happy to see that," said LJ Gunderson, the president of the Historic Landmarks Commission.

Nemlowill tells Port of disappointment

Astoria City Councilor Zetty Nemlowill approached the Port of Astoria Commission Tuesday night to share her disappointment over the Astoria City Council's 2-2 vote Monday that could prevent the enterprise zone from including any Port land in city limits.

Mayor Arline LaMear and City Councilor Russ Warr voted yes, while councilors Drew Herzig and Cindy Price voted no. Nemlowill said she couldn't vote because of a conflict of interest, namely Fort George Brewery and Public House, being included in the zone, which her husband Chris co-owns.

The Port Commission, Clatsop County Board of Commissioners and Warrenton City Commission all unanimously approved the enterprise zone.

LaMear said Wednesday

there's a meeting today between her, City Manager Brett Estes and Clatsop County Manager Scott Somers to talk about revisiting the enterprise zone. The next Astoria City Council meeting is April 6, which would allow it to vote again before the April 10 deadline for Somers to turn in the application to the Oregon Business Development Department.

Enterprise zones eliminate property taxes on new commercial and industrial development in their boundaries for three to five years, in the hope of attracting more business development, jobs and property taxes in the long term. They do not affect existing zoning laws.

Why no trust?

Port Commissioner James Campbell said he was alarmed at the distrustful attitude of the Astoria City Council toward the Port, adding that none of the other councilors come to Port meetings.

To a certain degree, Nemlowill said, there's a validity to that, referencing the contentiousness over the Astoria Riv-



erfront Vision, which the Port threatened to sue the city over because of its potentially affected property. City councilors were also irked

by the proposal by H.Y. Chen to develop North Tongue Point and other localities through his immigrant investor group Great Ocean; along with the proposed closure of the boatvard, which Executive Director Jim Knight canceled Tuesday night; and the cutoff of access on Gateway Avenue to the park Knight's said is to ensure safety by keeping pedestrians away from log trucks. The park is still acces-

sible through Industry Street. "I don't think that it's going to do us any good to dwell on bad issues in the past," Nemlowill said, adding she's interested in the good things the Port is doing and hopes the Port Commission has the people's best interests in mind.

Knight said he asked Estes to meet with LaMear to see about revisiting the issue before the deadline.

"Perhaps we need to find a time where the two commissions can have a retreat together," Knight said, who earlier in Tuesday's meeting was authorized to spend \$45,000 through June 30 on a public relations campaign, including about \$30,000 to improve the Port's website and another \$15,000 for a PR

"It just does feel like there's a fundamental misunderstanding in our intent to develop Port property," Knight said. He added that the value of the enterprise zone was for the future of the entire community.

"What a wonderful way to kick off your PR campaign," Nemlowill said at the end of her public comment Tuesday.

Clerk's office receiving ballots for Gearhart recall

The Clatsop County Clerk and Elections Department has received more than a fifth of the ballots from eligible Gearhart voters in the March 26 special election for the recall of Mayor Dianne Widdop.

Ballots were delivered to the post office March 6, and voters received the ballots starting March 9. As of Tuesday, the Clatsop County Clerk and Elections Department had received 206 ballots from a total of 928 eligible voters for a current voter turnout of 22.2 percent.

The number of registered voters is subject to change based on undeliverable ballots received, according to the clerk's office.

Voters have until 8 p.m. March 26 to return their ballots to the elections office, which will be open from 7 a.m. to 8 p.m. on election day. Ballots must be delivered to one of two official drop sites: Gearhart City Hall, 698 Pacific Way or the clerk's office, 820 Exchange St., Astoria. Postmarks will not be
