

Additional assault robbery suspects identified

Three more tied to Astoria home invasion

Anthony Victor Lane, the 30-year-old St. Helens man accused of assault and robbery in a home invasion in Astoria last month, did not act alone.

Three additional suspects have been identified and caught in connection to the case.

Tillamook residents Joseph Vernon Armstrong, 31, and Tasha Heather Van Dolah, 33, — who have both been in Tillamook County Jail since late April for other burglary and drug charges — are believed to be suspects, along with Kevin John Morse, 26, Astoria, according to the Clatsop County District Attorney's Office.

Court documents reveal Armstrong and Lane entered an Alameda Avenue residence April 3 wearing masks and demanded money and cellphones. They allegedly struck

two men with firearms and batons and took items from the home, according to police. The assaulted men had significant head and body injuries.

Two other women were injured in the residence from pepper spray at the time of the assaults.

Armstrong and Lane reportedly stole two purses, a cellphone, a stereo speaker and fled the residence in an Oldsmobile Bravada, court documents state.

A Seaside detective found the Oldsmobile Bravada shortly after the incident at Arnie's Café in Warrenton, but the vehicle was unoccupied.

Astoria Police, Warrenton Police and the Clatsop County Sheriff's Office first identified Lane as a suspect. Astoria Police put out a warrant for his arrest.

Lane became a suspect, in part, after he made a phone call to an inmate in Tillamook County Jail the day of the assault and robbery and said that "he was in trouble and that he was hiding in a swamp," according to court documents. Lane went on to tell the inmate "he had gone to do a hit

on a guy and that both his name and the inmate's name had been given out over the radio to police."

A Tillamook County detective overheard the phone call and informed the Astoria Police.

Oregon State Police found Lane April 28 on the 1800 block of South Roosevelt Drive in Seaside and booked him for a warrant arrest.

Lane pleaded not guilty Friday to four counts of first-degree robbery, two counts of second-degree assault, first-degree burglary, unlawful use of a weapon, two counts of first-degree theft, menacing and fourth-degree assault.

Circuit Court Friday — the same time as Lane.

He also pleaded not guilty to the charges.

"He has approximately 17 prior convictions, five of which are felonies," prosecutor Dave Goldthorpe said of Morse in court Friday.

Lane and Morse are being held in Clatsop County Jail on \$500,000 bail. Both are scheduled for early resolution conferences later this month. Lane, who is being represented by defense lawyer James von Boeckmann, will appear at 10:30 a.m. May 29. Morse, represented by defense lawyer Jerry Widawski, will appear at 2 p.m. May 27.

When Lane allegedly committed the assault and robbery, he was out on bail for a charge of felon in possession of a firearm that occurred in Seaside March 17. That charge will be handled at a hearing May 15.

Astoria Police Chief Brad Johnston said his department is still seeking other possible suspects related to the home invasion case.

"We are still working on other persons involved," Johnston said.

Galizio said the job in California offers the unique opportunity for him to use his experience from the academic and legislative world.

After his debate program at PCC was cut in 2004 because of budget constraints, Galizio ran for the Oregon Legislature to advocate for public postsecondary education, serving three terms in the state House representing the Tigard area. During that same time frame, he earned a Ph.D. in urban and public affairs from Portland State University.

Galizio was hired as president of Clatsop Community College by its board of directors in July 2010. During his time with the college, he has overseen a raft of cuts to the full-time faculty, along with the Jerome Campus Redevelopment Project and a recently passed bond measure to fund the Patriot Hall Redevelopment.

"It was very difficult," Galizio said of the staff cuts in his first couple of years at CCC. "It was extraordinarily difficult. But you have to try

and create a sustainable enterprise."

Galizio said he is excited about the near and long-term future of CCC, between the Patriot Hall Redevelopment and the relatively improved funding situation.

"The new honors program has picked up steam, and we'll have new programs with Patriot Hall," Galizio said.

A year ago, the Clatsop Community College Board of Directors approved the new honors program championed by Galizio as a way to improve the college's academic prowess for new students. With the redevelopment of the 93-year-old Patriot Hall, Galizio has said the college will add paramedic and exercise physiology degree programs, along with a substance abuse counselor certificate.

Moving with Galizio to California will be his wife Janice O'Malley Galizio, the special projects manager for the Astoria Parks and Recreation Department; 6-year-old son Giovanni; and 3-year-old twins Carmella and Matteo.

Astoria Police search for man wanted in kidnapping

Astoria Police are searching for Russell Wayne Deviney, a 48-year-old Everett, Wash., man who is wanted in connection with kidnapping a 15-year-old girl.

The girl, who had been missing from Sanger, Calif., since Saturday, walked into McDonald's in Astoria Monday evening and told the staff she had been kidnapped. Police responded at 7:32 p.m., contacted the girl and placed her in protective custody while her parents respond from their home in Sanger.

The FBI had been assisting with the search for the missing teen.

Police believe Deviney let the girl out at McDonald's, left her there and walked from the area to an unknown direction at about 7 p.m. He was last seen wearing a white shirt, blue jeans, black sweater and an orange baseball hat.

A 2004 Nissan Pickup, driven by Deviney, was found at the Macdonald's.

Astoria Police have been working in cooperation with the Sanger California Police Department and the FBI.

KMPH FOX 26 in Fresno, Calif. reported the girl was

chatting with Deviney on social media.

The girl's mother told the Fresno news outlet that she received a text message from her daughter's phone on Sunday. The message said the girl was scared, didn't know where she was, and wanted to come home soon. The latest text message from the girl's phone came from Seattle or along the Oregon-Washington board, according to the news report.
