Port tackles pressing issues in proposed budget

Port of Astoria staff proposed a \$15,455,434 budget for the 2015-16 fiscal year at the agency's first budget committee meeting Tuesday.

day. "The fiscal year 2015-16 budget (covering July 1 to June 30, 2016) empowers staff to evaluate the Port's most pressing needs, focusing on issues that will give the Port its best opportunities to support its existing customers while developing new sources of revenues," Executive Director Jim Knight said during his presentation Tuesday. "Building on the Port's 2010 Strategic Plan, this budget reflects that this is the time to strengthen our operational infrastructure, increase staff capabilities and position our organization to take advantage of new opportunities."

The budget committee will take comments on it at its next meeting Tuesday, before likely approving it. The Port's budget officer would then post a notice of a budget hearing, currently scheduled for June 16, and post a summary of the approved budget in The Daily Astorian.

The Port of Astoria's budget committee will meet Tuesday at the old Port offices, 422 Gateway Ave., to hear public comment on the budget and to approve it.

Budget before audit

The proposed budget comes out even as the audit for 2013-14 is being performed by Moss Adams, which had initially been trying to release it before the budget committee process started.

The Port's Financial Director Jim Grey said it's more likely the audit will come out near the end of May, after the Port's budget committee is scheduled to approve the budget. He said the current proposed budget is balanced and based off what the Port will likely take in and spend. The audit only affects the beginning fund balance.

"I haven't heard anything that indicated we were in a negative situation,"

The overall budget is 45 percent more than what's been projected for 2014-15, mainly because of an approximately \$5 million runway improvement project at the Astoria Regional Airport planned for this fiscal year, but put off until next. The project is mostly covered by grants

from the Federal Aviation Administration and Oregon Department of Transportation.

Investing in the Port

Port staff estimated between \$86 million and \$104 million in a "Master Capital Plan" ultimately needed to fix all the issues with its aging infrastructure. From there, staff whittled down the projects to a proposed \$11.2 million in capital improvements, split between medium and high priorities.

The high priorities made it into the proposed budget, which calls for \$6,346,113 in capital improvements.

More than three-quarters of that is for the airport project. The Port also proposes spending \$166,000 to remove obstructive trees from around the runways, also funded by an FAA grant.

The largest project beyond the airport is the \$436,000 proposed for dredging Slip 1, where log ships dock to take on timber from longshoremen and Astoria Forest Products.

The Port projects spending \$150,000 on Pier 3 stormwater treatment, although its master capital plan estimates the project costing \$6.5 million in total.

Employment at the Port

The Port's proposed budget included 82 positions, from the executive director down to part-time security staff.

Those positions translate to the equivalent of nearly 32 full-time jobs, according to the Port's budget, split between the central waterfront, property management, marinas, airport, boatyard, North Tongue Point, security and administration.

Port staff proposed a payroll of more than \$2 million, with benefits more than \$900,000.

The Port's proposed revenues and expenses for the 2015-16 fiscal year balance \$15,455,434, including several other major proposed expendi-

- \$487,600 in Oregon Department of State Lands leases for lands near or over navigable waters.
- \$1.1 million on fuel and oil and another \$1 million on utilities.
- \$350,000 on the rent for North Tongue Point, which it has the lease for through 2019.
- \$473,000 on professional services, including \$230,000 on legal fees, up from the \$30,000 projected for 2014-15; and \$120,000 on auditors and accountants.
- \$33,000 on advertising and promotion. In previous years, it spent less than \$10,000.

High-speed chase ends with arrest

An Astoria man was arrested in Seaside Monday night after taking law enforcement on a high speed chase that began on the beach, just north of Gearhart.

A Clatsop County Sheriff's Office reserve beach patrol officer spotted Timothy Leon Painter II, 36, driving a yellow Dodge Neon without a seatbelt on the beach. When the officer attempted to make a traffic stop, Painter took off southbound down the beach at 60 miles per hour, according to Sheriff's Office Sergeant Mike Smith.

Painter, who had a 34-year-old Hammond woman in the passenger seat, drove about two miles on the beach before exiting near Sunset Beach onto U.S. Highway 101. At that point, two Warrenton Police officers joined the pursuit, which reached 90 miles per hour, Smith said.

Seaside Police unsuccessfully place spike stripes. Painter then turned on Broadway Street in Seaside and struck another vehicle at Avenue A and Holiday Drive, which injured the other driver, according to the charges filed against Painter.

Painter fled from his vehicle and was arrested on S. Columbia St. and Avenue S in Seaside. He was booked into Clatsop County Jail at 10:07 p.m. Monday.

He is charged with attempting to elude police, reckless driving, reckless endangering, felon in possession of a restricted weapon, possession of methamphetamine, driving while license is suspended and a hit and run felony.

The woman in the passenger seat has not been charged with any crime.

According to court records, Painter, a former Aloha resident, was convicted in 2013 of similar charges of eluding police, criminal mischief, criminal trespass, unlawful entry into a motor vehicle and assault related to an incident in Clatsop County in January 2010.

Painter is scheduled to appear in Clatsop County Circuit Court at 1:15 p.m. Tuesday for an arraignment on the new charges.
