Jacobs, Tennant on championship course

Two-time defending champion Amanda Jacobs and 2014 runner-up Lara Mack Tennant both advanced with quarterfinal wins Thursday, on Day 4 of match play at the Astoria Golf & Country Club.

Jacobs and Tennant both had battles on their hands in Thursday's round, from Hillary McNeill and Sally Brands, respectively.

Jacobs was 3-up at the turn, while Tennant played a strong front nine, yet was only 2-up after nine holes.

Jacobs, McNeill, Tennant and Brands were in the same foursome Thursday, and all four made birdies on the eighth hole, with McNeill, Tennant and Brands all sinking long putts.

Eventually, Jacobs and Tennant were both able to close out their matches. Jacobs will now face Megan Roos in today's semifinals, while Tennant will have to get past Ale Kirakossian, as she seeks her ninth OCI title since 1990. Tennant's last

Randy Johnson finds life in focus after baseball

PHOENIX (AP) — With great enthusiasm, Randy Johnson talks of watching through a camera lens as wild dogs in Africa chased a leopard from the carcass of a gazelle, and how the leopard stayed warily nearby waiting for his chance. He witnessed female lions work to extract a dead baby elephant from a river.

He has photographed rock star friends from onstage and taken his cameras on USO tours to military installations around the world.

Somewhere along the way, Johnson's intimidating glare faded away. Often a broad smile was in its place. Johnson clearly is enjoying life after baseball.

"As you know, I was extremely intense when I played. I just felt like I was wired that way," said Johnson, who will be inducted into the Baseball Hall of Fame this weekend. "Since I retired I'd like to think that I'm not wound as tight because the expectations of whatever those expectations
