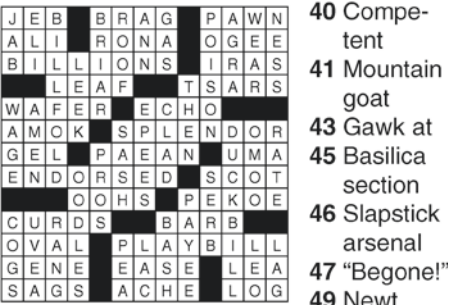

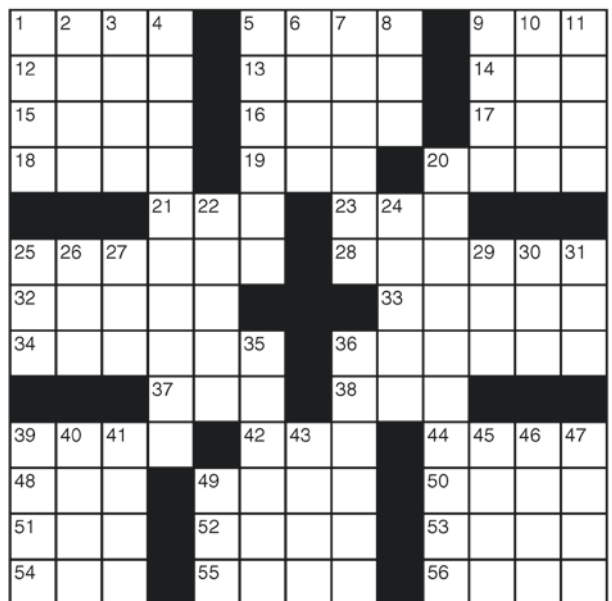

It must be in proper form and have proof of service on the Plaintiff's attorney or, if the Plaintiff does not have an attorney, proof of service upon the Plaintiff.

The complaint alleges that you violated the Residential Landlord-Tenant Act by providing a nonhabitable leasehold, by permitting contractors to repeatedly enter an area reserved to Plaintiffs under the rental agreement without Plaintiffs' consent or notice to Plaintiffs, and by issuing a notice of termination of Plaintiffs' lease in retaliation for Plaintiffs' complaints; that you discriminated against Plaintiffs on the grounds of race by delaying remediation of nonhabitable conditions and issuing the notice of termination in violation of ORS 93.360 and 659A.421; and other allegations against other defendants. On claims against you, Plaintiffs seek damages totaling \$12,800.00 against Mr. Falby and \$5,625.00 against Mr. Noble, a declaration that the notice of termination is invalid, their costs, disbursements, and reasonable attorney fees, and such other relief as is just and equitable.
