# **Stop delaying**



It's quite possible that Smith is severely depressed. At this time, the trial is set to begin in June 2017, nearly three years after the alleged crime took place. In my opinion, the delay in this prosecution process is ridiculous.

I understand that it's important to give both the defense and the prosecution ample time to prepare, but with the excessive pre-trial motions by the defense, this case has simply been dragging on for too long. There comes a time where we must all face the consequences of our actions, and I believe that Smith's time

is far overdue. As District Attorney Joshua Marquis said in court, "the clock starts ticking, and after three years the defense can move to dismiss the case." On April 1, you sell all the excited fisherman their required new fishing license for the year. On April 8, when the fish are finally in the river, you close all fishing. All the fish go up the river to be gillnetted above the dam, the lower river sport and commercial fisherman get few fish, and the game department gets all the money. A very good business deal.

The game department's recent emergency closure, with little advance warning, on the last day of an already short season, was an unwise decision. I found out about the Saturday closure on Friday afternoon. We had bought bait, tackle and food. We had friends and family coming from as far away as Seattle. Two of these people had taken time off from their jobs. This decision affected a lot of other people with similar

circumstances.

Businesses and professional guides had counted on this day for fishing. If the fish runs are in such dire conditions, then they should never have been opened in the first place.

They say that if the run improves, they may reopen the river at a later date. Wouldn't a better decision to have been to leave the river open the one more scheduled day, and then maybe reopen it a day or two later in the late season?

The game department's management policies seem to be doing a disservice to the fisheries resource and the citizens who are trying to enjoy it.

Thave been part of the effort to start a charter school since the closure of our grade school in 2013. I understood that the district didn't have the funds to maintain the building, or to move it out of the tsunami zone. It seemed that a tuition-free charter school would help the district and our children, since Seaside wouldn't have to build, purchase or maintain a building, and we would still have 5 to 10-year-old children attending school in town.

The district openly opposed us at first, but then changed tactics and said they would allow us to operate. They presented us with a list of "negotiable terms." Even though the norm is less than four conditions, they gave us 11. We thought we could work with those.

We didn't know there would be no negotiation, no cooperation, no working together. Saying they supported us was actually a plan to stall and weaken our efforts, while making it appear they cared about Cannon Beach grade school students staying near their families. They very much want Cannon Beach to support their efforts to build schools in Seaside, but they did not meet once with the charter school board to come to any sort of compromise.

Please don't believe our efforts have been as incompetent as they would have you believe. Many have worked very hard to overcome the numerous and varied obstacles to opening a charter school. Any board member would be happy to tell you what we have accomplished.

As an example, when the Seaside board said we were significantly short of funds, they didn't count the money the school district will have to give us to operate. For some unfathomable reason they felt we should have their state mandated funds in the bank. We had all of our building costs, curriculum funds, supply costs, payroll funds and more than the 10 percent extra that they required. We have been good stewards of the funds this community has donated to us.

Of course we want better. safer junior and high schools in Seaside. We also don't want 5-year-olds taking 45-minute bus rides (one way), we want to be able to easily volunteer at our local school, bring forgotten lunches, backpacks, and homework. We want to be able to get them quickly if they are ill. Not everyone can easily leave work and run to Seaside; not everyone has a vehicle to do this. I don't even want to imagine how long a 5-year-old will be separated from their family when an earthquake collapses roads and bridges.

In 2014 we had a wonderful vision, which the city council members of Cannon Beach shared when making plans for our school to share property they purchased south of town. Plans for not just a school, but also a community center for gatherings of all kinds. The possibilities are endless if we all work together. Please don't let this dream die. Thank you to all who continually support our efforts.
