The U.S. Coast Guard towed in a commercial vessel that began taking on water Tuesday morning 66 miles west of Tillamook Head.

Watchstanders at the Coast Guard's Air Station Astoria in Warrenton received a mayday call from the captain of the 48-foot fishing vessel Pura Vida at 3:36 a.m. Tuesday and sent out an urgent marine broadcast requesting assistance.



Multiple commercial fishing vessels and two U.S. Navy warships answered. The Coast Guard launched an MH-60 Jayhawk helicopter from Air Station Astoria, which delivered a watering pump to the Pura Vida. The nearby fishing vessel Western Edge delivered a second pump. A 47-foot motor lifeboat from Station Cape Disappointment delivered a third.

The 47-footer took the Pura Vida in tow toward the Columbia River and was later relieved by the 52-foot motor lifeboat Triumph from Station Cape Disappointment.

Power outage hits North Coast

A power outage hit Warrenton, Seaside and Cannon Beach Tuesday night as a result of a pole fire near a substation in Seaside on Roosevelt Drive near the outlet mall.

Pacific Power received reports of the outage around 10 p.m. Warrenton returned to power shortly before 11:30 p.m. Cannon Beach returned to power at 11:37 p.m.

Seaside was the last to return to power at about 12:40 a.m.

"There's no obvious cause," Tom Gauntt, a Pacific Power spokesman, said. "It doesn't look like anyone had a bonfire down there."

He said birds or a chemical reaction after rain may have caused the substation breaker to fail. "It's the same idea as the breaker box in your garage.'

The pole was badly damaged. Crews were "able to work around it and isolated it using different circuits," Gauntt said.

Gauntt said 15,324 customers were without power after the outage.


The Oregon Department of Fish and Wildlife is seeking a candidate to represent the state's seafood processing industry on the Fish Restoration and Enhancement Program Board.


The board includes volunteer representatives from sport


