PROGRAM OVERVIEW

Throughout the last century, Columbia Memorial Hospital has relied on community support to help fund excellence in healthcare. From the very first hospital to the move to the Exchange Street campus, donors have made the difference by making progress possible.

This is an even greater achievement when you consider that to free up \$1.00 for use in replacing equipment, maintaining facilities and retaining highly skilled staff, the Hospital has to earn \$12.50. In other words, to purchase a \$2,000,000 piece of equipment, or fund a program for one year, the Hospital has to generate \$25,000,000 in revenue to be able to reinvest \$2,000,000.

So, when philanthropic partners join in carrying out the mission, Columbia Memorial Hospital is able to achieve a standard of care that would otherwise not be possible.
