**Notice of Measure Election & Receipt of Ballot Title Publish pursuant to ORS 255.085(4b) State of Oregon County of Clatsop**

Notice is hereby given that a ballot title for a measure referred by Sunset Empire Park and Recreation District has been filed with the Elections Officer of Clatsop County, Oregon on July 25, 2018. The November 6, 2018 election will be conducted by mail pursuant to ORS 254.465. An elector may file a petition for review of this ballot title in Clatsop County Circuit Court no later than 5:00 p.m. August 3, 2018 pursuant to ORS 255.155.

**Caption:** Bonds to expand and update recreation facilities for residents/guests

**Question:** Shall Sunset Empire Park and Recreation District construct, renovate and expand their facilities by issuing \$20,000,000 general obligation bonds? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

**Summary:** If approved, this measure would fund the expansion of District facilities and provide indoor recreation space for District residents and guests.

Specifically, the bond is expected to finance:  
-Construction of a recreation center featuring indoor gym space, indoor walking track, group fitness, weight room and cardiovascular rooms and expanded preschool and youth program space;  
-Construction of additional family changing/gender-neutral changing rooms;  
-Redeveloping current District space to meet demand for dry-weather recreation and programming opportunities;  
-Parking and site improvements and furnishings and equipment;  
-Demolition and bond issuance costs.

The District would establish a citizen oversight committee to ensure proceeds are used for purposes indicated.

Bonds would mature in not to exceed 21 years from issuance and may be issued in one or more series. The estimated tax rate is \$0.70 per \$1,000 of assessed property value or \$70 annually for a home with an assessed value of \$100,000. Actual levy rate may differ due to changes in interest rates and/or assessed value.
