**18-068HOZ Appeal-** This is an appeal by the applicant of the Planning Commission's conditional approval of the following request:

A Highway Overlay Zone request by **Main & Main Capital Group** to build an 18,000 sq. ft. retail building at 825 Avenue N (T6-R10-S21DD-TL200, 500 and 10316). The subject property is zoned General Commercial (C-3). Although the primary access will be from Avenue N, the applicant plans to utilize the currently undeveloped portions of S Irvine and Avenue O in conjunction with the proposed development of the surrounding property.

The review will be conducted in accordance with Section 3.400, Appendix G of the Transportation System Plan, and Article 10 of the Seaside Zoning Ordinance which establishes the review criteria and procedures for development in the Highway Overlay Zone.

During the hearing, individuals may be called to a microphone by the Mayor to answer questions concerning any information submitted by the submittal deadline or any other information already in the record.
