

1. Conditional Use (CU19-01) by James Defeo to locate a Tourist Lodging Facility in an existing commercial building at 240 11th Street in the C-4 zone. (Map T8N-R9W Section 8CA, Tax Lot 3400; south 34' of lots 1 and 2, Block 58, McClure's). The following Astoria Development Code sections are applicable to the request: Articles 1, 2, 9 & 11.
2. Conditional Use (CU19-02) by Nancy Schoenwald, to locate a property management services office at 109 9th Street (Map T8N-R9W Section 8CB, Tax Lot 2500; Lot 4, Block 9, McClures) in the S-2A zone.
