The Astoria City Council will hold a public hearing on Monday, June 3, 2019 at 7:00 p.m., in the City Council Chambers at City Hall, 1095 Duane Street, Astoria. The purpose of the hearing is to consider the following:

1. Amendment Request (A19-04) by Community Development Director to amend the Astoria Development Code sections concerning miscellaneous issues, allow additional administrative variances, allow additional front and street side setback averaging, allow certain stairs as an exception to setback, allow arbor and gateways in fences, amend lighting standards, amend outdoor storage area enclosure standards, amend and add definitions, allow residential use behind commercial use in C-4 zone, codify several legal interpretations of code application, add 15' setback for parking from top of bank, expand non-conforming uses and structures to allow continuation of certain residential use, clarify off-street parking requirements, and other miscellaneous updates, City Wide. Development Code Sections 1.400, 2.430, 7.100, 7.110, 7.170, 8.040, 8.050, 11.140, 14.510, 15.020, Articles 3, 9, 10, 12; Comprehensive Plan Sections CP.005 to CP.028 General, CP.190 to CP.210 Economic Element, CP.215 to CP.230 Housing are applicable to the request.

The Astoria Planning Commission has recommended approval of the request. A copy of the application is available for inspection at no cost and will be provided at reasonable cost. All documents and information are available for review at the office of the Community Development Director at 1095 Duane Street, Astoria. Contact the Community Development Department, at 503-338-5183 for additional information.

The location of the hearing is accessible to the handicapped. An interpreter for the hearing impaired may be requested under the terms of ORS 192.630 by contacting the Community Development Department at 503-338-5183 48 hours prior to the meeting.

All interested persons are invited to submit comments on the draft application at the hearing or by letter addressed to the City Council, 1095 Duane St., Astoria OR 97103. The Astoria City Council reserves the right to modify the proposal or to continue the hearing to another date and time. If the hearing is continued, no further public notice will be provided.

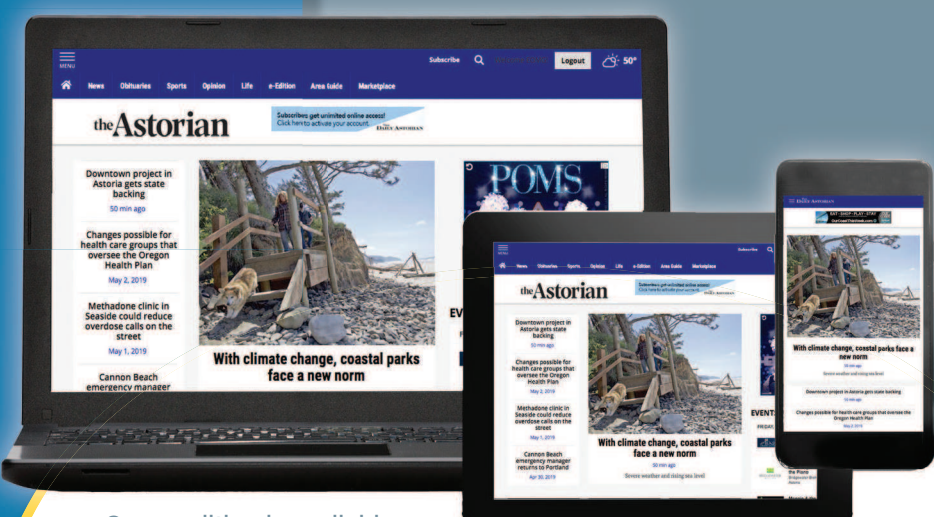
