An elector filing a petition with the circuit court must also file written notice of that filing with the Clatsop County Elections Department, 820 Exchange Štreet, Suite 220, Astoria OR 97103, no later than 5 p.m. the next business day following the day the petition is filed.

Caption: Prohibits enforcement of certain firearm regulations by Clatsop County employees.

Question: Should Clatsop County prohibit use of county resources for enforcement of certain firearms regulations and allow fines

Summary: Approval would prohibit Clatsop County employees or officials from enforcing any Extraterritorial Act relating to firearms or using any County resources to enforce such acts relating to

The measure defines Extraterritorial Act as any local, state or federal law or regulation that restricts a person's right to keep and bear firearms, accessories or ammunition.

Approval would prohibit enforcement of any of the following related to firearms: Any tax, levy or fee on the purchase or ownership of said items, any tracking requirements, background checks, confiscation orders, ownership of non-fully automatic firearms or accessories, and any restriction on the open or concealed carrying of firearms.

Violation would result in a fine of up to \$2,000 per individual or \$4,000 for a corporation. Exceptions: Does not apply to convicted felons or persons prohib-

ited from possession firearms by court order. The law also does not allow the possession of firearms in state or federal buildings.
