On **Tuesday, October 29, 2019** at 7:00 p.m. a public hearing will be held by the Seaside Planning Commission at Seaside City Hall, 989 Broadway, to take testimony regarding the following item:

19-063VRD: A conditional use request by **Leslie Dorsett** for a **three (3) bedroom** Vacation Rental Dwelling (VRD) permit with a maximum occupancy of **six (6)** people over the age of three. The property is located at **600 15th Avenue (T6-R10-S15CB-13002)** and it is zoned **High Density Residential (R-3)**. The review will be conducted in accordance with Article 6 and Article 10 of the Seaside Zoning Ordinance which establishes the review criteria and procedures for a Conditional Use. The specific review criterion for Vacation Rental Dwellings is included in Section 6.137 of the Ordinance

19-067CU: A conditional use request by **Sunset Empire Parks and Recreation District** that will allow the development of an indoor training facility at 1140 Broadway (T6, R10, 22BB tl:4801). The proposed metal building would be located north of the Sunset Empire's building near the northwest corner of the Broadway Park ballfield, where the current batting cages are located. The building would be approximately 56' by 86' and the development has been endorsed by the Seaside Parks Advisory Committee. The subject property is currently zoned Medium Density Residential (R-2). The review will be conducted in accordance with Article 6 and Article 10 of the Seaside Zoning Ordinance that establishes the review criteria and procedures applicable to the request.

All interested persons are invited to attend the meetings and submit oral testimony in favor or in opposition to the request. During the hearing, individuals that wish to offer testimony will be called to a microphone by the Chairman of the Planning Commission and asked to state their name and address for the record before they testify. Written testimony is also welcome and will be submitted to the Planning Commission at the time of the hearing. Comments may be delivered to the Community Development Department located at 1387 Avenue U or mailed to 989 Broadway, Seaside, Oregon 97138. A copy of the application, applicable criteria, documents, and evidence relied upon by the applicant are available for review at no charge. Likewise, a staff report will be available for inspection 7 days prior to the hearing. These materials can be reviewed at the Community Development Department. Copies of these materials will be provided at a reasonable cost.

Failure to raise an issue at the meeting, in person, or in writing, or failure to provide sufficient details to afford the Planning Commission and the applicant an opportunity to respond to the issue may preclude appeal to the Land Use Board of Appeals on that issue.
