Clatsop County will be receiving approximately \$5.9M in funding from the American Rescue Plan & FEMA. Staff is recommending creating a new Special Revenue Fund to better track this funding and avoid co-mingling with General Fund monies as well as prior Cares Act funding. In addition, staff is looking for approval to spend the unanticipated grant revenue.
