

Ballot Question: Shall Cannon Beach impose a 5% tax on the purchase of prepared food items?

Summary: This measure would impose a 5% tax on the purchase of most prepared food items ready for immediate consumption from businesses within Cannon Beach. The tax would be imposed on the customer, collected at the point of sale and remitted to the City by the business. Businesses may keep 5% of the amount collected to offset costs associated with collecting the tax.

Tax revenue would be used to fund the Cannon Beach Rural Fire Protection District emergency services and to assist in funding a new City Hall and Police Station, infrastructure and operations for the City. First year tax revenue would also be used to fund a grant program for businesses affected by the tax and operating at the time of implementation to offset initial costs.

An independent consultant estimates that the tax would generate approximately \$1.74 million in revenue per year and would primarily be paid for by visitors, spreading the financial burden of providing essential services across all users -residents and visitors. Currently, these services are funded primarily by residents.
